Wool Prices Low.

Though no regular wool sale was held here yesterday two local clips were disposed of during the day. Fearson & Johnson sold their woo, for the price of 12 1-4c, the buyer heing Defour, while the Charles Johnson clip was sold for 15 1-8c per pound, occording to the Pendleton

The activity yesterday came about as a result of an understanding between the buyers and a number of woolgrowers to the effect that if the growers would place their clips on sale the buyers would bid but would guarantee the growers the privilege of withdrawing their clips without injury. In the past growers who have withdrawn their clips after having received bids have sometimes met with difficulty in securing favorable prices. This caused many of them to hesitate about offering their clips yesterday until assured by the buyers that the withdrawal of the clips would not work against them.
