Republicans Begin Fight.

New York, Aug. 1.—A suite of rooms in the St. James building was occupied today by the Republican Congressional Campaign Committee and a hard fight for the control of congress

was formally commenced. Speakers and campaign literature will be supplied from the New York headquarters. Tons of pamphlets and leaflets will be printed and sent out from New York for distribution all over the country. Among the documents to be most widely circulated are Curtis' campaign handbook; Taft's Winona speech, in which he called the Payne-Aldrich bill "the best tariff ever enacted;" Speaker Cannon's speech at Kansas City; Senator Lodge's address on the high cost of living, and Attorney-General Wickersham's Chicago speech, in which he read the insurgents out of the party. Not a line nor a word from insurgent pen or tongue will be sent out with the sanction of the committee, which indicates that the "surgers" will find themselves "in bad," so far as aid and success from headquarters is concerned.

Put End to Joy Riding.

New York, Aug. 1.—"Joy riding will be a thing of the past in the metropolis and throughout the Empire state if the Callan motor vehicle law, which went into effect today, is strictly enforced. And the word has gone forth among reckless drivers of automobiles that the officials mean business and that violators of the statute will soon find themselves on the inside, looking out of a cell. Many chauffeurs and reckless drivers have been deprived of their tags and the good work will go merrily on, it is promised, until the whole pestiferous band of "joy riders" are given something resembling their just deserts. Every chauffeur has been "mugged" and other methods of identification have been made use of to the end that no guilty man escapes.

PAYS PENALTY ON OPST FOR ICT

SOUTHERN WOMAN ASSAULTED AND BROTHER SLASHED

Burning Follows Negro's Death by Bullets—Infuriates Mob

Alais, Ala., Aug. 1.—Bill Walker, a negro, was shot to death and his body burned today, by a mob that pursued him after he assaulted and fatally wounded Mrs. Nettie Gibson, a white woman, slashed her brother with a razor, and shot another negro and made his victim's wife flee with him. Mrs. Gibson is the wife of the superintendent on the farm where Walker was working. The negro lured her from the house by telling her that a neighbor had died. A short distance from the house he sprang upon her. She fought desperately but the negro stabbed her. Her little brother heard her cries and ran to her assistance, but the negro slashed the boy with a razor.
