# THE FAIR

## CONTRACTOR DARLEY GIVEN THE SHOP FOUNDATION JOB

Contractor C. T. Darley has been given the sub-contract from the Hicks & Co., firm of San Francisco, for the construction of cement foundations to house the new machine shops and blacksmith shops now being rushed in this city by the O. R. & N. through the San Francisco contractors.

Engineers for the Hicks & Company contractors, represented by Superintendent Goodauff, arrived yesterday, and as a preliminary, surveyed the ground for the three new 110-foot stalls to be added to the round house, but today commenced surveys for the machine and blacksmith shops. When the new stalls are built, there will be forty feet to the southeast corner of the machine shop. The buildings for the two departments are practically one. They touch, and one wall, will be the north side of both buildings. That wall is to be ninety-five and 132 feet long, 227 over all, but the machine shop will create an L. The machine shop is square, 132x132, while the blacksmith shop is only sixty-five feet wide. In time the blacksmith shop will be widened to the south to conform with the building proper.

**Many Facilities Added.**  
Four tracks will run to the machine shops, and there will be as many engine pits. Electric cranes are provided for in great numbers and enormous sizes.

Just as soon as Contractor Darley can construct the 1000 cubic feet of cement foundation, the contractors will have the wall material ready to rear. There is no loss of time permissible in the spending of the \$160,000 appropriation, and the entire track-laying facilities will be taken up, for

the new shops are to stand on the "flat" west of the round house.

The local O. R. & N. storehouse platform is to be doubled in size and covered with corrugated iron roofing. J. H. Martin will have the division store house here, and it will be the biggest outside of Portland, by far.

The inlets, east and west, for engines going to the round house, are to be changed. They will come up the track which is now being used for storage purposes, just by the storehouse platform on the east and by the present site of the dog house on the west.

A new cinder pit is to be constructed close to the site of the store house.

A new weighing scale is here and will be installed just as soon as the new switching track is built. The new track will run through a point where the old store house now stands.

New standpipes, two in number, are to be erected on either end of the round house.

Material for relaying the tracks between here and Huntington is being assembled here in great quantities. Angle irons and the like to the number of about fifty car loads, are stored here now. The steel is to be assembled here next, and then the work will commence, probably next spring.

### Politician in Trouble.

### GRAY WILL LIKELY BE PLACED UNDER ARREST TODAY

Adolph Newlin Signs Complaint Against Three Former Witnesses

Charged with "unlawfully offering to procure for another a place on a jury," W. A. Worstel, government co-operative weather observer in this city, Reverend Frank E. Gray, pastor of the Baptist church here, and Ben Morgan of Wallowa, who was the detective in the recent bootlegging trials, are being arrested this afternoon. Mr. Worstel was formally served with the warrant of arrest this morning and as Mr. Gray is in La Grande, and says "The police can find out where he lives" it is presumed his warrant will be served this afternoon sometime. Morgan may not suffer arrest until tomorrow.

The case will end up in the circuit court likely. When the men are arrested it is presumed they will waive examination and the law is likely going to be given a test. In the event that they waive examination the case will go to the circuit court for hearing. Justice Williams can, under provisions of the law, dismiss the case for lack of evidence.

Adolph Newlin is the prosecuting witness.

The case has grown out of the admission of the three men in question while on the witness stand in the recent case when Newlin was charged with bootlegging, that they went to Sheriff Childers with a list of names from which he might draw a panel for the then pending cases, they understood, they said, that jurors were hard to get. The men said on the witness stand that they had gone over a list of about thirteen names and agreed that they might be suitable as jurors in the cases.

Mr. Worstel affirmed at the time that he did not know that he was violating the law.

The warrants have been partially drawn for a week or more, but it was not until the past twenty-four hours that they were given their finishing touches.

### Ban on "Be Gob" Business.

Burlington, Vt., Aug. 23.—That the "be gob" and "be jabbers" variety of Irish jokes are becoming less frequent, as a result of the crusade of the united Irish societies, is the statement of delegates to the state convention of the Ancient Order of Hibernians. For several years the Hibernians, assisted by other organizations of Irishmen, have waged warfare on the vile caricatures of their race which have long passed for wit, with the result that the most offensive of the so-called "Irish joke books" have been withdrawn from circulation.

## GUN CLUB HOLDS ELECTION

MASTERTON AND HARRIS OF ELGIN ARE OFFICIALS

Title Formally Changed and Other Business Transacted Sunday.

Imbler, Aug. 22.—Special.—A meeting of the Eastern Oregon Blue Rock Association was held at Imbler Sunday, and the name changed to the Union and Wallowa County Sportsmen Association. The following officers were elected for the ensuing year: H. G. Masterton, Elgin, president; S. E. Harris, Elgin, secretary and treasurer. A motion was made and carried, that any town intending to hold a shoot should notify the secretary at least thirty days in advance of date of shoot, and that any town holding a shoot be required to raise not less than \$100 added money to be put up as cash prizes in the different events.

Enterprise, Ore., Aug. 23.—(Special.)—There is a project on foot in Wallowa county, looking to the establishment of a summer normal at the head of Wallowa Lake, near here. A press representative waited upon Superintendent of Schools J. C. Conley, of this city, today and in an interview with him the latter said:

"I have been considering the plan of establishing a summer normal at the head of the lake for some time. This idea has also received the hearty support of Union county educators and teachers. While the matter can be made a splendid success, once it is established."

Professor Conley then went on to detail matters incident to the project. He pointed out that in the absence of any summer normal the teachers of the county and surrounding section of Eastern Oregon were compelled to go elsewhere for normal work, unless, as during this summer, a normal was held in Enterprise. But a normal as a fixture, is the idea. The erection of suitable buildings and the installation of suitable apparatus and the securing of suitable prominent educators for the work and for the delivery of pertinent lectures—these matters were rehearsed by the county superintendent.

That official pointed out, too, the supreme opportunity for the teacher to combine a summer term of school of ten weeks duration, with the finest outing Oregon offers; at the head of a magnificent lake where the altitude is high enough to assure cool, pleasant weather entirely through the hot season, and where fishing is excellent. The teachers of Eastern Oregon in such event, could be permitted to bring tents and lapse into camp life, during the entire ten weeks of school.

### Hearing in Land Office.

A hearing involving relinquishment, deed, and various other steps concerning the possible courses of public lands, was on at the land office this morning. Edwin A. Snow, an attorney of Boise was charged by the government of having wrongfully deeded some land to the George Palmer Lumber company. The land in question lies in Wallowa county.

### Railroad Bridges Burned.

Chicago, Aug. 23.—The Milwaukee & Puget Sound Railway has practically lost all of their bridges and traffic will be tied up for at least 2 weeks. The Northern Pacific expects to be able to resume service soon.

There are some new fires in the outlying districts that may cause some trouble but a state of general improvement is noted. It is reported this morning that the towns of Taft and Haughan, Deborgia and Bryson are in ruins.

### RECEPTION TO McLEOD FAMILY

Popular Pastor and His Wife will be Tendered Reception Tomorrow.

Many in La Grande will take advantage of an opportunity to again meet Rev. and Mrs. H. E. McLeod tomorrow evening, when the Methodist congregation will attend an informal reception at the church in honor of the minister and his wife, who have been transferred to Yale. They have moulded a large host of warm friends in this city during their one-year stay.

### KREIGER SHOWS VITALITY

When Given up for Dead Recovers Slightly and Lives Through Night

Showing great physical endurance and vital strength, Councilman George Kreiger is still alive this afternoon. He was given up for dead yesterday morning, but recovered during the evening to such an extent that he could converse with his friends, and his doctors and friends revived hope. He sank soon after 8 o'clock again, and all through the night was thought to be dying. At 2 o'clock this afternoon he was still in the same condition, showing no appreciable decline. It is now believed he may live for several days, unless his heart weakens.

## AGED ELGIN NANN IS INSANE

BELIEVES HIS BROTHER IS PURSUING HIM.

Case is Violent One and He will Be Sent to Asylum Tomorrow.

Laboring under the insane theory that he is being pursued by his brother and that he is in danger of bodily harm, William Moiles, an aged resident of Elgin, is locked away in the county jail today, pending the arrival of a deputy from the state asylum. He was brought to the city late last evening by the sheriff, and few cases of insanity in this county have been so violent. The aged man has a large circle of friends.

He was examined today and adjudged insane, and will be sent to the asylum tomorrow morning, likely.

Another strange case of insanity was also heard today when Robert Roberts, for some time an inmate of the county poor farm, was committed to the asylum.

Roberts believes he has a vast amount of money and he is going to build a large hospital for aged people. He mumbles about his riches to himself almost continually, and with him and his strange mania, and the Elgin man a raving maniac much of the time, the county jail is anything but a cozy retreat this afternoon.

### Will Call Special Session.

Sacramento, Cal., Aug. 23.—Governor Gillett today issued a proclamation calling a special session of the legislature for September 6, for the purpose of adopting amendments to

the constitution to be submitted to the people, so financial aid can be given the proposed Panama fair at San Francisco. Probably it will be levied.

### Indict Mob Members.

Newark, O., Aug. 23.—Additional developments of a sensational nature may follow the re-convening here today of the special grand jury called to consider the lynching of Carl Etherington, an anti-saloon detective, on July 8, last. Fifteen alleged members of the mob have already been indicted on charges of first degree murder, and others were charged with rioting and assault and battery.
