Section 1. That the Mayor and Recorder be, and thery are hereby authorized to enter into a contract with the Oregon Rallroad and Navigation Company to furnish to said Company water for its use at La Grande, for C H. D.—Physician the term of one year from the 30th day of September, 1910, for the sum of \$300.00 per month, the amount to be used not to exceed 300,000 gallons each twenty-four hours.
