PIONEER RECORDER RECALLS ACTION OF LONG AGO.

During Terribly Cold Weather, Noted Records on Deed Books.

Not only is the fact disclosed that years ago it was much colder in Union county than it is now days, but also that the county deed record book was made a weather bureau record is the interesting light thrown on what is almost ancient history in this county. Yesterday W. T. Wright, the pioneer of Union was at the court house and he was reminded through conversation about weather and records, that in 1883 when he was recorder of conveyance and the court was at Union, he had made notations in the deed book as to the weather. Since then other recorders have been through the books time and time again but it is doubtful if they have seen these notations-plain enough when attention is called to them, At least County Recorder Snook has not seen them during his career in the office. The notations are made on the bottom of the page and might easily be passed over unnoticed.

Wright Placed Them There.

In the winter of 1883 Mr. Wright temperature was reached, he decided to make official notations of them and then in later years there would be absolute proof of what records had been reached. He wrote it in the deed book and it is not likely that they have been seen from that day to yesterday. Mr. Wright knew just where he had placed them and a hasty research revealed them readily enough.

The notations made are:

3, '83 52 below zero. Reported at Union, Feb. 4, 38 below zero. Reported Feb. 5, 61 below zero. At North Powder the same day, 34 below zero, (Signed) W. T. Wright."
