Willard N. Jones, the timber dealer and political worker, has been finally sentenced to serve four months in the county jail and pay a fine of \$10,-000, to which fine Mr. Jones definitely and finally accedes. The primary sentence imposed upon Jones was one tiary and a fine of \$2,000.

Mr. Heney made no recommendation in court with regard to Hays, and will have to dispose of this case later, probably after the appeal for pardon has

been acted upon. George Sorenson and a few others will have to stand trial again, as the fighters against the special prosecutor been especially good. and will probably face a jury on

two charges yet pending against him. Some of the defendants in what is known as the Blue Mountain case are not dismissed, the charges being Binger Hermann in this connection being

selected from the others. In connection with the Hermann case, the special prosecutor filed a long statement explaining why he recommended the dismissal. This went at considerable length into the detalls of the case, and recited the poer health of Mr. Herrman, his trial and the hung jury. His friends are immensely relieved at the dismissal. as the narrow margin by which the fury hung before was not at all com-
