

WACCINERS DEVOLVER OPPOSI-TION TO SUPERVISION.

Selfishness the Motive for Attacks on State Supervision Bill.

Chicago, March 28. - (Special) -State regulation of fraternal insurance as proposed in the "Mobile bill' of the insurance commissioners, now pending in Illinois and in a score of other states, and recently enacted by five legislatures, has brought out the CITY COUNCIL OF LA GRANDE skeleton from the fraternal insurance closet. Deception and misrepresentation are charged to a small but energetic faction of ostensible fraternalists which is opposing the bill notwithstanding that the two big federations of fraternal societies have endorsed and are supporting it.

Resolutions have been adopted by convention of the Ladi s of the Maccabbees of the World, the largest f the fraternal societies for women hat some societies are not in fact 'fraternals" although they claim to b This society has consistently urged the need of adequate rates to insure

The effect anticipated by these socalled fraternal orders of state supervision and publicity of accounts is pointed to as an evidence of the selfish motives which prompt the opposi-

Aft r various "whereas's" the convention declared: "This misrepresentation, misstatement and opposition proceeding from societies working under the guise of fraternal beneficiary sociaties but which are not true fraternal socities, is dangerous and inimical to the stability and future sounda whole and to the millions of persons dependent thereon." It is add by way of good measure, that

ception being practiced by thes tended fraternities as to the effect and nature of the measure recommended by the national convention of insurance commissioners and endorsed by the fraternal fiderations is "contrary to the interest of the individual members." The societies "which for immediate profit and self-interest' have misrepresented the measure were denounced as "not worthy of the confidence bestowed by the public upon fraternal beneficiary societies."

"Such opposing societies cannot be nature," the resolutions declare, "in that they seek for selfish and unworthy reasons to prevent the general good of their members."

Reference was made to "scandalous mergers and misuse of funds,' which the proposed law will prevent, the allusion being to recent exposures of the purchase and sale of small societies at profit to the managers. The pending measure was endorsed by this womens organization, which has a membership of 159,000 and the largest reserve in proportion to insurance issued of any fraternal organization established in the United States.

It was an actuarial investigation by the Ladies of the Maccabees of the World which a few years ago reversed the attitude of life insurance companies regarding women. The investigations showed that women were better rather than poor risks than men. As result women are generally accepted for insurance.
