BAKER AUTO ACCIDENT.

Girl Run Down by Unknown Driver and Quite Badly Injured.

The little seven year old daughter of Mrs. Dora Byers of Center street was struck by an automobile while crossing the street near the high school yesterday afternoon, and was knocked down and badly hurt. That her injuries were not worse is a mystery, according to several who witnessed the accident, relates the Baker Democrat.

The car contained three men, and when the child was struck, they stopped, but only for a moment. Miss Graves, a teacher in the high school, who came out as the accident happened, cared for the little one, and asked the driver of the car what his name was. He refused to answer, so she obtained the number of his car, which was 5504.

Dr. Huff was called and rendered medical assistance to the child, whose injuries proved painful, but not alarming. Several witnesses of the affair thought they recognized the driver, but would make no positive statements, as they did not see him long enough. Up to a late hour the car had not been identified, nor had the driver owned up.

MANY GIRLS TO BE OLD MAIDS

New York to Be Home of About 50,000 Old Maids, Says Authority.

New York, March 30.—(Special.—) That there are 50,000 girls of marriageable age in New York who are doomed to become old maids was the statement made here this week by a prominent Finnish educator in addressing a meeting at Mrs. Belmont's new suffrage colony on Long Island. As proof of his statement, he pointed out that there are that many more women than men in the city and that consequently, no matter how attractive the members of this army of 50,000 might be, they could not wed for the reason that there are not enough men to go around. He added that there are so many men whom no woman would want to marry that the number of spinsters actually would be much larger than this. Dr. Jackola, the authority for these statements believes that the strength of the suffrage movement comes from this preponderance of women in the population, quoting as an example his own country where there are 100,000 more women than men and where women have the ballot. In view of the fact that women are in a majority he believes that they should have the right to propose, and not be compelled to wait until asked by some slow-going male before having a chance at matrimony. This last suggestion was heartily applauded by the suffragists.
