ORDINANCE NO. 528, SERIES 1911. An ordinance relating to the use of streets for signs, advertising purposes and amending section 4 of Ordinance No. 453, Series 1910, and declaring an emergency.

The city of La Grande does ordain as follows:

Section 1. That section 4 of Ordi_ nance No. 453, Series 1910 be, and the same hereby is amended to read as

Section 4. No person owning or occupying any building or premises, or other person, shall place or cause to be placed or maintained upon the street or sidewalk, or shall suspend or cause to be suspended over the sidewalk in front of such building or primises or any other place within the city of La Grande, any sign or advertisement, or place any goods, wares or merchandise upon the sidewalk for the purpose of display, advertisement or otherwise, or shall suspend or cause to be suspended. maintain or cause to be maintained over the street, beyond the line of the curb in front of any building or prem.

ises or other place whatsoever, any sign, advertisement or flag, except on holidays, election days and days of cure any case of itching, blind, bleedpublic parade; provided, however, that electric signs may be put up and maintained in front of buildings over the sidewalk or streets at a height over said sidewalk of not less than 15 feet, or over the streets at a height of not less than 20 feet; provided, further, that goods, wares and mechandise may be placed on shelves in front of buildings, which shelves shall be at least eighteen (18) inches above the sidewalk and hung on hinges so as to be let down at the close of business, and said shelves shall be made with round corners and shall in no case extend over the property line more than twelve inches; and provided further, that when electric signs are to be placed over the street or sidewalk application therefor, setting forth the plan of said sign and the place where the same is to be located, shall be made to the recorder of the city of La Grande for a permit to so use the streets of the city and the space above the same, and upon approval of said application by the chairman of the street committee, said permit shall be granted and not
