FAWCETT GIVES Decision

ELGIN HAD NOW RIGHT TO APPEAL
DISPUTED GAME.

Can Be No Appeal on That Particular

Issue Aftirms Critic. Roscoe Fawcett, sporting editor of the Portland Oregonian, to whom was referred the question of baseball law arising over filing of a protest by Elgin of a decision of Umpire Mullen, in the La Grande-Elgin gams here two weeks ago, has handed down his opinion upholding La Grande's contentions in their entirity. Mr. Fawcett, deemed to be the best authority on baseballdom on the coast, took considerable time in preparing the decision and in no instance does he allow room for an appeal. "There is no appeal from the decision of the umpire on balls and strikes," he writes, "and the scoring of the second La Grande man was due to a pure matter of negligence on thepart of the Elgin team." It will be remembered that at the time the play came up the bases were full and with Kait at bat, three and two on him, Childers, who was on third, started for home as the last ball was delivered. and the umpire called it a ball which would force Childers to score and give Kail a base on balls. While the ball which was missed by the catcher, lay on the ground and the Eigin backstop was arguing with the umpire, Proe

Mr. Fawcett holds that if the umpire says Kail did not interfere with the catcher, and that Aubin was in the pither's box, which Elgin contradicts, there is nothing to do but take it.

There is positively no appeal.

Ordinance No. 530, Series 1911.

An ordinance prohibiting the disposal and distribution of patented medicines, powder or other articles; providing a penalty for the violation of this ordinance and declaring an emer-

The City of La Grande does ordain os follows:

Section 1. No person or persons shall throw upon or leave at the premises, dwelling house or property of another, or cause the same to be done, any patent medicines, patented article or any other or different kind of medicine, or powder, either liquid or solid, unless such person shall personally hand to or leave with an adult member of the family such article.

Section 2. Any person violating the provisions of this section, upon conviction thereof by the Recorder of the City of La Grande, shall be punished by a fine not exceeding \$50.00 and in default of the payment of the fine shall be imprisoned one day in the city jail for each Two Dollars of said fine.

Section 3. Inasmuch as the health of the public is in danger by such conduct, and this ordinance is necessary to preserve the peace, health and safety of the City of La Grande and its inhabitants, an emergency is hereby declared to exist, and this ordinance shall take effect immediately upon its passage by the Council, approval by the Mayor and publication in one is_sue of the La Grande Evening Obser-


