## APPLE SHOW IS PROMISING

ANNUAL EVENT WILL BE BIGGER THAN EVER.

Spokane Show Company Announces Many of Feature Plans for Show.

Spokane, Wash., Aug. 22.—(Special)—Twenty thousand dollars in cash premiums, in addition to gold and silver trophies, will be awarded in competitions, free and open to all, at the fourth national apple show and harvest festival in Spokane, November 23 to 30, inclusive. Plans have been completed to exhibit more than 2,000,000 of the highest grade commercial apples grown in the United States and Canada in a temporary structure covering four and a half acres of ground, the features being 15 or more full carload displays.

Arrangements are under way for a series of growers' conventions and country life meetings, at which some of the foremost experts in the country will discuss the educational phases of apple culture, dealing also with the problems of marketing the orchard products at home and abroad. Practical orchardists will give demonstrations of modern orcharding, from the breaking of the raw land to harvesting the crop, and introducing features designed to assist producers in securing adequate returns from the land.

Five experts of international reputation will be engaged to pass judgment on the various exhibits, ranging from carloads to single plates of five apples. The sweepstake contest has been eliminated this year and in its stead there will be contests with added prizes and premiums on standard commercial varieties.

The management of the National Apples Show, Inc., headed by E. F. Cartier Van Dissel, has received a fund of \$35,000, subscribed by citizens of Spokane to carry on the exposition which is not a money making enterprise in any sense of the term, and it is estimated by R. H. Rice, secretary and manager, that fully \$15,000 more will be expended in staging the pageants in connection with the harvest festival in the business district during the week of the show.

"The 1911 festival was literally forced upon us this year by the business men and residents generally of Spokane," said Harry J. Neely, first vice president of the National Apple Show, Inc., "as we were given to understand early last spring that St. Paul wanted the show in connection with the land exposition there the coming fall. However, about a week ago it was learned that the land show people could not see their way clear to undertake such a large enterprise, chiefly because of the expense and lack of room to properly display the exhibits and it was put up to this organization.

"We told a delegation of prominent citizens that if Spokane would guarantee a fund of \$35,000 the National Apple Show, Inc., would stage a larger and better competitive show than has ever been seen in the western country and in addition give a week of carnival festivals in the downtown business district. A committee was organized and the first day's canvass resulted in subscriptions amounting to \$23,000, with the rest of the money needed in sight. We have every reason to think that the show the last week in November will be the most important and interesting in the history of Spokane and that it will be a credit to the entire country."

lation in the people's favor. He said that congress will bow to the people's will and they should next turn their attention to the judiciary, intimating the recall was a good way of doing it.

### Final Cabinet Meeting.

President Taft today called a final meeting of the cabinet, the last to be held for some time. Vice President Sherman and Champ Clark called to bid the president farewell but were unable to see him on account of the meeting. Scores of congressmen were similarly disappointed.

Washington, Aug. 22.—Three big measures made into laws is about all the congress of the United States was able to show today after five months and six days of unceasing grind. They were the Canadian reciprocity agreement, the bill for publicity of campaign contributions before elections and the bill for the admission of Arizona and New Mexico to statehood, after their original constitutions had been emasculated in the political mill.

Another finished product turned out was the reapportionment bill fixing the membership of the house at 433.

Enthusiasm nevertheless is the portion of the Democratic leaders who are filled with joy on account of the campaign material they have fashioned from the happenings of the session. A great scheme of tariff revision, which the Democrats declared would cut down the tariff tax on the people has crumbled under the big heel of the president's veto. Reciprocity was the only reason given by the president for convening the extra session on March 15.

Ten Democratic tariff bills, one revising the wool schedule, another placing meat and bread on the free list have been lost in the grind. Some more have died aborning. Two of them, the wool bill and the free list bill were vetoed and the Democrats failed to pass them over the veto.

By combining with the insurgent republicans in the senate the house Democrats put their tariff bills through that body in some semblance of their original shape. But the combination blew up at the last moment and only the complaisance of the standpat Republicans allowed the passage of the cotton bill to which were attached revisions of the iron and steel schedules, the chemical schedule the cotton machinery schedule as an amendment providing for free coal from Canada.

Taft's declaration that he would sign no tariff bills until the tariff board reports on them put a damper on the Democrats ardor for tariff revision.

When adjournment was in order the bill providing for the direct election of senators was left in conference. The house passed it and the senate amended it—and it is not a law yet.

## TWO DIVORCE CASES FILED

CHAS. JOHNSON MOVES FOR ANNULLMENT ORDER.

Lilly Nelson Alleges Desertion by Her Husband, Axel Nelson.

Two divorce cases were filed in circuit court yesterday and will likely come to trial at the next session of circuit court. The first one recorded was that of Chas. Johnson against Nora Johnson, in which the plaintiff alleges cruel and inhuman treatment. Johnson asserted several days ago his wife has left him and warned no one to charge her accounts to him.

The other suit for divorce was that of Lilly Nelson vs. Axel Nelson, the plaintiff alleging desertion.

### Japanese Cabinet Resigns.

Tokio, Aug. 22.—Owing to the national discontent over Marquis Katsura's failure to carry out the proposed increases in army levy, the cabinet including Katsura will resign August 25, it was announced today. The emperor will appoint Marquis Saionji leader of the Seiyukai party as premier to organize the next cabinet.

### Famous Painting Sold.

Paris, Aug. 22.—The noted painting of Mona Lisa by Leonardo D'Venci, one of the famous pictures of the world, was stolen from the Louvre today. The police closed the Louvre this afternoon and succeeded in finding the frame.

### Forest Fires D'raw Population.

San Diego, Aug. 22.—The entire population of Fall Brook is fighting the forest fire burning between Fall Brook and Tenecula, according to reports today. Heavy damage is already done.

### President's Congratulations.

In promising to open the groundbreaking ceremonies of the Panama-California exposition, President Taft told Director General D. C. Collier that he congratulated San Diego on its enterprise, and he added that he was taking an especial interest in the exposition because of the demonstration it would make of irrigation, reclamation and forestation.

noon, President Taft sent a message vetoing the cotton bill, passed late last night.

He scored the methods by which the houses adopted the measure and asserted the bill had been passed without proper consideration of the facts.

In the message Taft said "My objection to the cotton schedule is that it was adopted with no investigation, no information of satisfactory character in regard to the effect it will have on the industry of this country in which capital is interested to the extent of \$19,000,000 to \$21,000,000 and the value of the probable product is \$629,000,000 and which industry affects at least \$100,000 to \$200,000 persons involving wages amounting to \$148,000,000.

"The bill would not become effective until Jan. 1 and before that time a full report will be submitted by the tariff board based on a most thorough investigation. It will show comparative cost of all elements of production and manufacture of cotton products in this and other countries.

"The house ways and means committee's investigation did not cover the facts showing the comparative cost because the committee was preparing a bill on the tariff for a revenue basis and their view of the proper bill was avoidably at variance with their theory of protection. I am pledged to support a policy of moderate protection; I cannot approve the measure violating this principle."
