NORTHERN MAN WANTED

INDICTMENTS RETURN-
ED UNEXPECTEDLY
BY GRAND JURYSALT LAKE MAN AMONG
THOSE ARRESTED AT NOON.

Clarence Darrow Will Probably De-
fend the Men Who Are Charged With
Conspiracy in Times Dynamiting—
Labor Leaders Seek to Get Labor
Support in the Defense.

Los Angeles, Dec. 30.—The federal grand jury unexpectedly returned indictments shortly before 11 o'clock today. Olat Tivetmoe and Anton Johansen of San Francisco, two of the most prominent Californian labor leaders and J. E. Munsey, secretary of the Structural Iron Workers of Salt Lake were arrested immediately on the indictments of the jury, which for weeks has been sifting the Times dynamiting. They were arrested in the courtroom at a given signal.

Positive assertions that there are nine indictments was made this afternoon by the United States district attorney, McCormick. All are charged with conspiracy to transport dynamite. Besides three arrested are the two McNamaras, David Caplan, M. Schmidt and a missing dynamiter, who name is unknown as yet.

"We have been arrested," said Tivetmoe, "I will make no statement. Our case will be tried in the courts and not in the newspapers." Malcolm McLaren for the Burns agency said they were indicted for conspiracy to transport dynamite between states, and when Chief Deputy Marshal Sittle and his aides arrested the men they arose without a word and accompanied him into the ante room of the marshal's office. They evinced no surprise.

The federal grand jury adjourned until Tuesday this afternoon.

Clarence Darrow will defend the accused labor leaders. They will probably be arraigned this afternoon. Labor leaders here are already trying to line up the labor element behind the accused.

Despite Sittle's statement that no further arrests would be made during the day, it was learned that they are hunting for another well known labor leader from the north. Job Harriman the recently defeated mayoralty candidate, arrived at the federal building this afternoon at the defendants' attorney. He started to hunt ball which it was unofficially stated would be \$5,000 for each prisoner. Regarding whether he would try the case, Darrow said: "I am not sure. I am still tired out as the result of the strain in the McNamara case. I shall think the matter over before making a definite answer." Eric Morton, of San Francisco, publisher of a labor organ, said "I am very much surprised at the arrests. I think labor people of this state will stand solidly behind these indicted men. I believe labor will take the position they are innocent until proven guilty."

PERSONAL NOTETHANKS ENGINEER THEISEN FOR

White House Missive Extends Warm
Christmas Greeting and Appreciation

William H. Taft, president of the United States, has sent his personal congratulations to Engineer Pete Theisen for safely and painstakingly guiding the locomotive that drew the Taft special through Eastern Oregon when the executive was on his journey through the west. Engineer Theisen yesterday received a missive directly from the white house, signed by President Taft and expressing in warm terms the executive's appreciation to not only Mr. Theisen but all the engineers who made the trip in safety possible. Naturally Mr. Theisen prizes his white house note immensely. The letter is dated at the white house on December 18th and reads:

"Mr. Dear Mr. Theisen. I only now find opportunity to express to you as one of the engineers whose painstaking care and skill made my long trip possible without accident, my thanks and appreciation.

"With a Merry Christmas to you and yours, I am, sir, very yours,
WILLIAM H. TAFT."

Mr. Theisen's hand was on the throttle in the midnight ride over the mountain division and without the slightest mishap the special was taken over this division. Mr. Theisen took the engine at Huntington, and it is almost a strange coincidence that his turn fell to the task for he is one of the oldest men in point of service in this section of the state.

It is doubtful if the veteran engineer has ever received a Christmas gift or remembrance that he will value more highly than this little piece of paper with the executive's name boldly scrawled at the conclusion of the warm expression of appreciation.

KANSAS CITY
BANK CLOSEDINVESTIGATION SHOWS HEAVY IN-
DEBTEDNESS.

Bad Paper Taken Over From Another
Institution at Fault.

Kansas City, Mo., Dec. 30.—The American Union Trust company with \$162,000 paid up capital failed to open today. It was less than a year old. About 3,000 depositors are affected. Banking officials in charge say investigations have not proceeded far enough to make any statement.

The assets are \$395,000 and bills payable \$493,000. It was decided to not open the bank pending an investigation of paper gotten from a day and night bank which has been financially embarrassed. President Massey says the depositors will be paid in full.

In July the bank took over the paper of the night and day bank. Since then the day and night bank was financially embarrassed through the arrest of several of its officials.

HUNT TRIP IS
PARTY MOTIVE100 YEARS AGO HUNT ATE DOG
FOR SUPPER HERE.

Celebration at Hot Lake Marks Ann-
versary Service at Lake.

Hot Lake, Ore., Dec. 30.—(Special)—Hot Lake held a centennial celebration of its own last evening. The occasion was the one hundredth anniversary of the first visit to the Grande Ronde valley by white men. The historical features regarding this party of pathfinders are about the same as those pertaining to all other "first visits." The hope of finding better trapping streams and a desire to reach some base of supplies. According to the recorded accounts of the usual exploring party their journey was marked with numerous hungry days, and sleepless nights. The record of the Hunt party seems to have been up to the average in this respect. Their journal is replete with mention of hardships, fireless camps, and meatless

CRACK LIMITED IN DITCH.

St. Paul, Dec. 30.—Five passengers, if not more were killed in a wreck on the Great Northern crack coast train, the Oregonian, two miles east of Sharon, N. Dak., today. Four bodies have been recovered. The train went over a 15-foot embankment. Eight injured were taken to a hospital.

The number of dead is still unknown but this afternoon the Great Northern general manager received a report saying that three were killed and several injured.

At two thirty this afternoon the list of dead is unobtainable and the wires are down. Meager reports say the injured were taken away in sleighs. Four cars burned up, and only the engine and mail car held the tracks. A corps of physicians was rushed to the aid of the injured from Devils Lake.

Fredericks Goes East.

Los Angeles, Dec. 30.—Carrying with him the original confession of McManigal in which the names of labor leaders are said to be mentioned in connection with the dynamiting conspiracy Attorney Fredericks left today to testify before the grand jury at Indianapolis. Lawler announced today that the local jury would not return indictments until January 2.

UNION CENTRAL
MUST REBUILDSTATE COMMISSION ORDERS SUCH
ACTION.

Union School District Again Refuses
to Issue Warrant.

Union's stirring events promulgated by the avowed intentions of the Union Central to abandon its line from Union Junction to Union thereby obliterating Union town from the railroad map, have been taking a turn toward popular satisfaction. The railroad commission has handed down its findings on the basis of the hearing taken a Union a few weeks since. The railroad is ordered rebuilt and service resumed. What the company intends to do is not made known but courts will no doubt hear more of the edict from the railroad commission.

Union Refuses Warrant.

Union, Dec. 29.—(Special)—Another of the series of school elections connected with the construction of the Union high school building was held in the assembly room Thursday afternoon. The house was filled beyond its seating capacity, probably 125 people being in attendance at the opening of the meeting. The meeting was called for the purpose of voting upon a proposition to issue a district warrant amounting to approximately \$2,300 in payment of a balance due Mr. Rush as contractor on the building.

Chairman Levy called the meeting to order and the call was read by Secretary Caspar. Directors M. F. Davis and C. J. Johnson were also present. Attorney B. F. Wilcox, representing Contractor Rush, made a statement covering the case, which was responded to by Attorney W. A. Terrall, representing those opposed to the issuance of the warrant for the payment of the balance due Mr. Rush.

Perjury Charge Preferred.

Growing out of the endeavors of Mr. Workman of Wallowa county to wed Miss Houghton also of Wallowa without parental permission has resulted in perjury charges being preferred against the witness to the attempt to get a license. The Union Republican remarks:

"Marshal Huffman Wednesday arrested Ray Clark at Union under order from the sheriff's office charging Clark with perjury in the matter of making affidavit as to the age of a certain young lady who hailed from the Wallowa country and who expected to wed a man who was with her. Clark was taken to La Grande Wednesday night. It is understood that the other man in the case has been arrested also.

Later—Clark was placed under \$700 bonds. Workman, the principal in the case, was taken back to Wallowa county."

DELAY REYES SENTENCE.

Believed Government Anxious to Wear
Off Pro-Reyes Feeling.

Mexico City, Dec. 30.—Semi-official advices here today state that it is unlikely the Reyes trial for the rebellion will be held before February. The government apparently wants a pro-Reyes feeling throughout the country to abate. Reyes is in good spirits and received several visitors in his cell today.

POLICE GUARD
PEACE DINNERBIG DETACHMENT IS TO
PRESERVE ORDER
THIS EVENINGBRILLIANT DINNER WILL
BE AMPLY PROTECTED

Special Train Coming From Washing-
ton—Commission Asked to Supply
Police "As There Might Something
Happen"—Taft Expected to Reply
Hotly to Roosevelt's Accusations.

New York, Dec. 30.—"We will have peace if we have to fight for it." This describes the situation before the widely heralded peace banquet here tonight at the Waldorf Astoria at which President Taft will be the honored guest. Eighty police will be present to guard Taft and the diplomats and to preserve order.

Usually pacific, it is expected Taft will tonight reply hotly to Roosevelt's allegations that the peace treaties now before congress—to applaud which the banquet is held—were conceived in the "spirit of hypocrisy."

Others who will speak at the dinner are Andrew Carnegie, Henry Claws and Charles Towne. A special train from Washington will bring numerous foreign diplomats to grace the feast. It will arrive this afternoon and return to the capitol at midnight. The presence of police at the banquet tonight resulted from a call of Samuel Thomas, one of its promoters, who told the police commission, Waldo, that "Something might happen."

Taft on Way.

Washington, Dec. 30.—President Taft Washington, D. C., Dec. 30.—President Taft left Washington today for New York where he will attend the "peace" dinner tonight. He took no action on Charles Morse's pardon case. He didn't even read the surgeons' official report on the New York banker's precarious condition. It is reported that Morse is slowly dying.

ITALY SEEMS DEFEATED.

Turks Have Ammunition to Last Fully
Two Years—Italy Short.

Gsarian, via Tunis, Dec. 30.—Unprejudiced correspondents attached to the Turkish army are of the opinion that the prospects favor a long struggle which will be hopeless for Italy. The Turks and Arab allies are well equipped and have ammunition for two years. After a forty day march across Libyan desert 2,000 trained desert warriors from Fezzan have just arrived here with large supplies of food. A successful invasion of the interior by the Italians seems to be impossible.

Colorado Frozen Up.

Denver, Colo., Dec. 30.—The mercury went to zero over the state today, and 16 below at Sterling. The ranges are covered with a foot of snow and live stock situation is serious. Trains are from ten to 12 hours late. It is below zero in Montana also.

LIFER RETURNS
TO DON SUITWEST HONOR MAN HELPS TO
CLEAR MORTGAGE

After Working for His Wife and Chil-
dren, Returns to Prison.

Salem, Ore., Dec. 30.—Fulfilling his word of honor that he would return to prison and complete his life sentence for the murder of George Carter at Grants Pass, William Mack today donned the prison stripes and resumed his work in the penitentiary.

Mack was allowed his liberty in June by the governor to aid his wife, two children, and her two parents in Spokane who had mortgaged their home to aid in his defense.

The mortgage being paid, Mack voluntarily returned to prison.

DEATH TOLL IN
PAST YEAR BIGBIG MEN OF WORLD
CALLED BY
DEATHCHRONOLOGICAL SURVEY OF
EVENTS IN 1911 IN DETAIL

Grim Reaper Has Taken Away Some
of the World's Greatest Characters
in the Past Year—Political, Histori-
cal and Other Events of the Year
Are Noted.

New York, Dec. 30.—The list of the noted men and women who were removed by the hand of death during the year just closing, contains the names of many distinguished makers of history, at home and abroad, of many leaders, statesmen, diplomats and prominent members of the various professions, men of the church, scientists, educators, artists and others too numerous to mention.

Among the prominent Americans claimed by death during the year were many close identified with public life.

John Marshall Harlan, associate justice of the United States supreme court Stephen B. Elkins, United States senator from West Virginia and formerly secretary of state under President Harrison, and Wm. P. Frye, for 30 years United States senator from Maine, were probably the three most widely known. The list includes the following United States senators and ex-senators: Charles J. Hughes of Colorado; Roger Q. Mills, of Texas, author of the Mills tariff bill; Thos. H. Carter, twice United States senator and founder of the Prudential Insurance company of America. Others were Hiram A. Tuttle and John McLane, former governors of New Hampshire; George Washington Glick, former governor of Kansas; Frank W. Benson, secretary of state and former governor of Oregon; Abram Chamberlain, ex-governor of Connecticut; Fletcher Dutton Proctor, former governor of Vermont; Congressmen and ex-Congressmen Nehemiah Day Sperry, "father of the rural free delivery" system; Sydney E. Mudd, of Maryland Edmond H. Madison of Kansas; Henry Clay Loudenslager of New Jersey; James P. Latta of Nebraska; Geo. W. Gordon of Tennessee, commander in chief of the United Confederate Veterans and James Proctor Knott, ex-congressman and former governor of Kentucky.

Among the noted Canadians who died during the year just closing were Sir Charles A. P. Pelletier, lieutenant governor of Quebec; Desire Girouard, senior judge of the supreme court of Canada; Sir John Carling, a former member of the Canadian cabinet; L. J. Forget, member of the senate; Geo. Johnson, former chief statistician of Canada; Archbishop Denis O'Connor and Archbishop Fergus Patrick McEvoy, of Toronto; Rev. William Patrick, principal Mitoba Presbyterian college; James Bell, professor of surgery, McGill university and Israel M. Ross, a prominent railroad builder of western Canada.

Among the noted foreigners called by death during the past year were many statesmen and men of affairs known throughout the world, including Peter A. Stolypin, premier of Russia; Baron Northcote, formerly governor general of Australia; Sir Charles Dilke, a prominent leader of the liberal party in England; Buenaventura Correo, ex-president of Panama; Baron Banffy, former Hungarian premier; Maurice Rouvier, twice premier of France; Martinez Campos, president of the supreme court of Spain; Henry Maurice Berteaux, the French minister of war; Gen. Brun, former French minister of war; Prof. Maschika Shimose, inventor of the high explosive used by the Japanese navy and Marquis Jutaro Komura, former minister of foreign affairs of Japan. The list also includes Princess Clotilde, aunt of the present king of Italy; Maria Pia, formerly queen dowager of Portugal and Louise, the dowager duchess of Devonshire.

The list of noted churchmen removed by death during the year includes Archbishop Patrick J. Ryan of
