## SMALLPOX AT PILOT ROCK BAD

SPREAD OF CONTAGION IS CONTINUED.

Said to Be a Mild Form and No Serious Results.

Reports from Pilot Rock today indicate that the spread of smallpox in that community continues. Fourteen cases already are under quarantine. ### MOHLER CASE UP.

White Slayer Taken in La Grande Is Sent to Portland.

Charles M. Butts, accused of bringing Nellie M. Sams as a "white slave" from Eureka, Cal., to Astoria on the Alliance last year, was brought into federal court this morning, captured after a search that has extended over several months. Butts said to Deputy District Attorney Johnson that he had only \$35 in the world, and requested that, for this reason, the federal court add to the expense of his prosecution by obtaining a lawyer for him, says the Journal. This request was denied by Judge Wolverton. He will be tried Thursday.

An order to remove G. H. Mohler, an alleged white slaver, from Oregon to Walla Walla in Washington, was granted this morning by Judge Wolverton. Mohler was arrested in La Grande. He has a number of aliases, and is said to be wanted both in Washington and Montana.

### Hoppe Vs. Sutton.

New York, Feb. 6.—Billiard enthusiasts are looking forward with keen interest to the 18.2 championship, match between Willie Hoppe and Geo. Sutton, which is to be played tomorrow night at the Hotel Astor. It will be the second time within six months that these two noted cue experts have contested for the championship title. In the previous match in this city last November Hoppe succeeded in easily defeating the veteran Sutton. The latter was disappointed by his showing and challenged again. In his practice work the past few weeks Hoppe has displayed excellent form and he expresses confidence in his ability to retain his title.
