TAFT SUPPORT IS WIDESPREAD

ALL SECTIONS OF OREGON SUPPORT EXECUTIVE.

State Executive Committee at Portland Is Encouraged.

(Portland Oregonian.)

With delegations in nearly every county of the state desirous to organize Taft campaign committees to work in conjunction with the Taft committee of Multnomah county, steps were taken yesterday at a meeting of the Multnomah committee at headquarters in the Selling building, to establish outside organizations at once and to spread the general campaign committee throughout the state as quickly as possible.

This action was taken when letters were read to the committee by Ben Selling, chairman, from many republican leaders in various parts of the state, saying that the republicans everywhere want steps to be taken at once to organize the county committees.

Telegrams were sent last night to the leaders in all the counties asking them to start at once the organization of committees and requesting them to report as soon as possible the names of committee officers, that they may be approved by the Taft headquarters in Washington.

Harney Strong for Taft.

That Taft sentiment is strong in many parts of the state is apparent from expressions of delegations which visited the committee yesterday and gave their opinions as to the outlook in their districts. Among the visitors was a delegation from Burns, comprising State Senator Gowan and Elmer Purlington, Lincoln Hutton and Isaac Constant.

"We have very little opposition to contend with in Harney county," said Senator Gowan. "Everyone in our part of the state is more than satisfied with conditions during the Taft administration. There is no criticism of any account and as yet no opposition to his re-election. I believe the president is drawing in strength. So strong are we for President Taft that we have started a Taft committee of our own and we are enlarging the membership constantly."

"We will have a good republican majority when the returns come in," said Mr. Purlington. "Harney used to be a democratic county but this has all been changed."

Union Also in Line.

Union county also was heard from at yesterday's meeting. J. H. Peare, chairman of the Union county central committee, wrote Chairman Selling that the committee is desirous to set to work to bring about the re-election of President Taft. Mr. Peare forwarded a list of stalwarts among the republicans of that county who will be formed into a strong organization that is expected to do great work in that part of the state throughout the campaign.

A number of letters from other counties were received, all of which indicate that Taft sentiment is strong and that he is wanted as the republican candidate for president again this year.

The progress of the campaign which is under way by the Taft committee has been marked during the last few days, according to a report made by Chairman Selling. He said the work is being rushed as rapidly as possible.

The work of preparing literature regarding the enviable record of the president during his present administration was started last week and hundreds of letters were dispatched in preparation for the public meetings which are to be held throughout the state.

The committee will meet again next Monday afternoon at 4:30 o'clock when it is expected the campaign will be well started not only in Multnomah county, but also in most all the other counties of the state.
