## COUNCIL HEARS MONTH REPORTS

### A. G. LONG DISCUSSES FIRE APPARATUS.

Tells Council of Merits of Both—Semi-Annual Report Filed.

With Mayor Church, City Recorder Humphreys and all councilmen present, the city lawmakers held an active session last night. The annual reports of officers, and the budget of accounts against the city were read and referred to the respective committees to be reported on two weeks hence.

The city auditor's report was read and referred and will be published within a day or two. It shows the city's financial status at the present time and is exhaustive in its scope. Along with the filing of the semi-annual report, Auditor Mansager reported the changes necessary to put the city's account on a daily balance basis. This was in answer to a request from Mayor Church inculcated in his initial message to the council. The auditor's recommendations pointed out that no great changes would be required in the present system of books but that an accountant be given complete charge of the books. This would be realized at a small added expense over the present system of employing an assistant to the recorder from the first to the 10th of each month. This report was referred and will probably be acted upon shortly.

A. G. Long, the Portland fire apparatus agent was before the council with an interesting word picture of the merits of the various kinds of fire fighting apparatus which the city must purchase soon. Without urging the city to buy either type, Mr. Long pointed out what other cities are doing and spoke of the merits of the horse drawn and the motor drawn vehicles. "I have both to sell," said Mr. Long, "but I am here to advise you as to the merits of both and the

city council can make its own selection."

Some board sidewalks for North La Grande were ordered in and in each instance they will connect up walks already built.
