## FEE QUESTION TO BE AIRD

LITIGATION OVER ESCHEAT FEE DUE.

Attorney General Ordered to Prevent Payment If Possible.

Litigation over the fee allowed Attorneys Cochran & Cochran in the Morrison escheat case, is apparent. According to information from Portland, Governor West has required the attorney general to take some action to prevent the payment of the fee of \$7,500, which was allowed for the four years work—approximately—in which the attorneys worked on the case. C. E. Cochran today affirmed that he would of course defend his claims to the fees and it is expected that protracted litigation will be precipitated should the attorney general find that there is any room for action to attempt the payment of the fee.
