Notice of the recorder of the city of La Grande, Oregon, of the assessment of section 1, of sewer district No. 1, of the city of La Grande, Oregon.

Notice is hereby given that the assessment roll for the improvement of section 1, of sewer district No. 1, of the city of La Grande, Oregon, under the provisions of Ordinance No. 577, series 1911, entitled, "An ordinance declaring the cost of installing a sewer in that portion of section 1 of sewer district No. 1, of the city of La Grande Oregon, under contract with the G. H. Sutherland company; determining the property benefited thereby; levying an assessment thereon to defray the costs and expenses of the improvement; providing for the assessment roll of the same and directing the entry of said assessment in the docket of
