IN THE NAME OF THE STATE OF OREGON, You and each of you are required to appear and answer complaint filed against you in the above entitled suit, on or before the last day of the time described in the order of publication of the summons, to-wit:— on or before the 6th day of May, 1912, and if you fail to so appear and answer, the plaintiff will apply to the court for the relief demanded in his affidavit.

The relief demanded in plaintiff's complaint is that a certain mortgage, given by one John A. Shira, plaintiff's predecessor in interests, on the S 1/2 of SW 1/4 of Section 14 and the N 1/2 of NW 1/4 of Section 23 in Tp. 2 South of Range 36 E. W. M., in Union County, Oregon, on the 17th day of November, 1890, to secure a debt of \$780.00 payable on or before July 1, 1891, less a payment of \$500.00, be cancelled; that said mortgage was duly recorded on the 18th day of November, 1890, in Book K, on page 108 of the mortgage records of Union County, Oregon, in the office of the recorder of conveyances of said county—on the grounds that the same that the debt secured thereby has been paid, or that more than ten years have elapsed since any payment has been made on said debt; that the same is null and void and is a cloud on plaintiff's title to said land.

That a certain timber deed given by plaintiff's predecessor in interests, on the very 1st day of April, 1892, conveying to the defendants, W. D. Starbird and D. H. Starbird doing business under the name of W. D. Starbird & Co., also, be cancelled, as a cloud on defendants' title to said land on the grounds that the plaintiff has had open, notorious and adverse use of said land under claim of right against all the world and more especially against said defendants for more than ten years last past; and that the defendants, and each of them, be barred from all rights, title, estate, interests in or lien upon said land or any part thereof.
