

SOCIALIST IS DENIED A VOTE

SUFFRAGE WITHHELD BECAUSE APPLICANT IS SOCIALIST

JUDGE HANFORD OF SEATTLE ESTABLISHES NEW PRECEDENT

Possibility of Curtailing Thousands of Socialists of Their Votes Is Seen in Ruling Made at Seattle. "Law-giver" U'Ren Calls Judge Crazy Who Decried the Verdict at Seattle.

Seattle, May 11.—There is great interest in the decision of Federal Judge Hanford in cancelling the citizenship of Leonard Olson, of Seattle, because he admitted he is a socialist, and a frequent of assemblies of socialism in which he participates as a speaker, advising propaganda for radical changes in the institutions of the country, and because he entertained these views when he applied for naturalization papers.

This is probably the first case in the history of the country where a man's citizenship was cancelled by court procedure, and if sustained may lead to deprivation of the citizenship rights of thousands of socialists, according to legal opinions here. There is much strong criticism against Hanford's decision.

U'Ren Calls Hanford Crazy. Oregon City, Ore., May 11.—Commenting on the Hanford decision, W. S. U'Ren, the noted reformer, said: "I am the most outrageous decision I ever heard of. Hanford is a survivor of the dark ages. He is crazy with standpatism."

Will Ask Removal. San Francisco, May 11.—Cameron H. King, vice president of the San Francisco Labor Council, said: "In Francisco Labor Council, said, in commenting on the Hanford decision, born citizens for participating in a strike and for being a socialist, is the rankest tyranny. Hanford is notorious for his enmity to labor. I shall move at the next meeting of the labor council to have a protest against the latest tyranny sent to President Taft with the request of Hanford's removal."

OROZCO CENSORS WIRES.
Impossible to Learn Definite Facts About Rebels' Position Today.

El Paso, May 11.—All efforts to get in communication with General Orozco's forces, which are expected to fight a decisive battle today with the federals under Huert, have failed. Orozco is censoring the wires, making it impossible to get an accurate line on the movements of his plans.

Strike Stands Unchanged.
Chicago, May 11.—With the strike of the newspaper pressmen 10 days old, no settlement of the dispute seemed likely today. The publishers insist they are selling more papers than when the strike began. Morning papers delivered their editions without any trouble.

Plans are under way for the formation of a new Stereotypers' union to take the place of Local No. 4, whose charter was taken away because the members struck in sympathy with the pressmen, and refused to return to work when ordered to do so by the executive council.

RICHESON'S FATE HANGS MAY CHEAT THE CHAIR

ALIENISTS PROBE BRAIN POWERS JOINTLY.

Un-Frocked Pastor's Fate Depends Largely on Findings of Four

Boston, May 11.—Four celebrated alienists are today examining Rev. C. V. T. Richeson, in jail here for the murder of his former sweetheart, Avis Linnell, in an attempt to determine his mental condition. They are Dr. Lloyd Briggs, Morton Prince, Henry Stedman and E. O. Leonard. If a majority of the alienists declare the condemned man insane, Governor Foss will submit a petition to the state executive council for commutation of his sentence. He is under sentence to die May 19th.

Steal Wool From Flock.
Eastern Oregon has been noted for instances of bold lawbreaking but it is doubtful if ever any more audacious or impudent crime has been pulled off about Pendleton than that committed Wednesday night when two or three daring spirits drove a band of sheep from the John Wynn flock on McKay creek, sheared them of their fleeces, sent them back home minus their wool and then brought the wool into Pendleton and sold it without the precaution of removing the brand, says the Pendleton East Oregonian. Sheriff Taylor is now on the track of the thieves and it is expected that he will capture them before they can make a getaway.

Mr. Wynn was surprised yesterday morning when he found twenty-eight of his finest sheep unfleeced and an investigation proved to him that they had been driven off to some distance during the night, clipped, and turned back. He came to the city immediately and reported the matter to the officers and the fleeces, four in a sack, were found in the warehouse of Jimmie Hackett, that well known wool and hide buyer having made the purchase just a short time before. When spread out the Wynn brand could be plainly seen.

Furnished with a description of the men by Hackett and their identity furnished by the victimized flockmaster had furnished, Sheriff Taylor set out in pursuit and was expected to arrive back with his prisoners last night but now it is believed that the men, becoming aware that Wynn had discovered his loss, have fled from the country with the sheriff still on their trail.

HIBBEN VESTED WITH NEW ROBE

INAUGURAL PROCESSION AT PRINCETON IS THRILLING

GRIER HIBBEN SUCCEEDS WILSON AT OLD SCHOOL

Varied Line of Interests Paraded Before Admiring Students at Princeton Campus When Nassau Hall Is Scene of Spectacular Procession—Alumni Figure in the Ceremonies.

Princeton, N. J., May 11.—The president of the United States, the chief justice of the supreme court and a host of other distinguished public men, scholars, scientists and theologians today paid tribute to John Grier Hibben as he pledged himself before a great concourse of people that filled the campus in front of historic Nassau Hall of Princeton university to be the president of America's fourth oldest educational institution. The new president, who has been a member of the Princeton faculty for more than twenty years, succeeds Woodrow Wilson, who resigned the presidency of the university in October, 1910 after his nomination as the Democratic candidate for governor of New Jersey.

The inauguration ceremony this morning was held out of doors, with the principal actors on a temporary platform built on the steps of Nassau Hall, the oldest and most famous of the college buildings. Over the platform waved the yellow and black banners of the university, while the great seal resplendent in colors was also in evidence. The colors and seals of the oldest American colleges, Harvard, William and Mary, Yale, Pennsylvania, Washington and Lee, Columbia, Brown and Dartmouth also were used in the decorations.

The preliminary interest in the day's ceremonies centered wholly in the inaugural procession. The chief marshal of the day headed the line, followed by the president of the alumni association and the president of the university, the fellows of the corporation, the official representatives of the state of New Jersey, and the dignitaries, civil, educational and military. Conspicuous in the line were the delegates and guests from a hundred institutions of learning, garbed in the academic gowns of their colleges, and their degrees indicated by their gorgeous hoods. While the procession wound its way through the college grounds the spectators were taking their places in the great rows of seats that spread out over the campus in front of Nassau Hall.

The following was the order of the principal exercises of the day:

Choral—Veni Creator Spiritus (Palmestri), the alumni chorus.

Prayer—Dr. Henry Van Dyke, professor of English literature.

Oath of office administered by Justice Pitney of the Supreme Court of the United States.

Charter and keys delivered by John Alkman Stewart, senior trustee.

Inaugural address of the new president.

One Hundredth Psalm by the alumni chorus.

Benediction—Rt. Rev. Edwin S. Lines, bishop of Newark.

At the conclusion of the inaugural exercises the principal participants and guests attended a luncheon in the university gymnasium. President Taft, Chief Justice White, President Lowell of Harvard, President Hadley of Yale, President Butler of Columbia, and Dr. Francis L. Patton, president of the Princeton Theological Seminary, delivered addresses at the luncheon.

In 1890 he published his "Inductive Logic," which is extensively used as a textbook in schools and colleges. Princeton University dates from 1746, in which year a royal charter was granted for the founding of the institution. In its earlier career it was known as the College of New Jersey. Many men of wide fame have served as president of the institution. Among the most distinguished of them were Rev. Aaron Burr, father of the famous Aaron Burr; Johnathan Edwards, the famous Connecticut Calvinist; and John Witherspoon, who was one of the signers of the Declaration of Independence.

ARCHBALD ON DEFENSE, FIGHTS

BOLAND BROTHERS OF SCRANTON FORMED CONSPIRACY

SUCH IS DEFENSE SET UP IN TODAY'S HEARINGS

Men Who Are Bringing Chief Charges Against Court of Commerce Judge Are Accused of Forming a Conspiracy to Undo Archbald—The Defense on Cross Examination Scores Today.

Washington, May 11.—Trying to show that the Boland brothers, of Scranton, Pa., conspired to obtain the impeachment of Judge Robert Archbald, of the United States commerce court, Attorney A. J. Worthington, for Archbald, today resumed the cross examination of Edwin Williams, a Scranton coal miner, who accused Archbald of profiting from sales of coal piles in which he used his position to aid him.

Interstate Commerce Commissioner Mayor will follow Williams on the stand.

Edwin Williams, the Scranton coal miner who accuses Judge Archbald of the commerce court of profiting from sales of coal piles by using his official position, was cross examined and admitted that W. P. Boland of Scranton suggested that he get a letter from Judge Archbald regarding the Erie Railroad's Culp pile which figured in Archbald's alleged business transactions. The witness denied Boland ever said he was trying to trap Archbald.

Baker Y. M. C. A. Plans Change.

At the meeting of the building committee of the Y. M. C. A. with the architect, E. B. McNaughton, a further pruning of the specifications were made so as to make them fit the funds. It is likely that the specifications will be redrawn and the contract probably let when this work is completed. The man to whom the contract will be awarded is probably one of the three lowest bidders, R. R. Sparks and C. W. Baldwin of Baker and Joseph Gassman of Welsler.

The bids of these three men as to the specifications as sent back this last time were all approximately \$35,000, while those of the other bidders ran much higher, some over \$40,000. The work of redrafting will be pushed so as to get the work started as soon as possible.—Baker Herald.

MIKADO'S AGREEMENT BROKEN
Violation of Immigration Agreement Said to Be Frequent.

San Francisco, May 11.—Flagrant violation by Japan of the "Gentlemen's agreement," entered into by the mikado and the United States by the terms of which Japanese laborers are not to be allowed to emigrate to the United States, is charged in a statement here by A. E. Yoell, secretary of the Asiatic Exclusion league.

Missed Titanic: Rench's Baker.

There was a happy reunion yesterday when J. Dale arrived from England to visit his daughter, Mrs. J. W. Day, of Eleventh street, says the Baker Herald. Mr. Dale had planned to sail on the Titanic but business had changed his plans at the last minute and he was saved from the disastrous trip.

He sailed on the Arabic April 23 and had a pleasant voyage. His delight in seeing his daughter and to greet for the first time his six months old grandson, Harry Malcolm Day, was apparent.

Allen Testifies in Own Defense.
Whiterville, Va., May 11.—Nervous, and pale, and in a shaking voice almost inaudible, Floyd Allen, a member of the notorious Allen bandits, on trial here for his life for shooting several persons in the Hillsville court house, testified today in his own behalf. Allen recited his own history, and swore that he told his attorney at the Hillsville trial, which was interrupted by the murders committed by the Allen gang, that he intended to "take his medicine from Judge Thornton Massie."

Passenger Hits Freight.
Vincennes, Ind., May 11.—Two persons were killed and seven injured today when a southbound train of the Chicago and Eastern Illinois railroad crashed into the side of a freight train.

ISMA PETTED BY FRIENDS

CRITIC'S PAPERS

CHEERS GAVE SHIP-OWNER ON JURY.

Has No Fault to Find With Senate Committee.

Liverpool, May 11.—Arriving on the steamer Adriatic today, J. Bruce Ismay, managing director of the White Star line and owner of the wrecked Titanic was given an ovation here, as he left the dock where his friends had gathered to meet him. He was heartily cheered.

Ismay shook hands with a number of those gathered about. He declared the United States senate committee under Chairman Smith which probed the Titanic wreck, and before which Ismay was one of the chief witnesses, treated him well. Ismay characterized as unfair the American newspapers' attacks by which he was made the target of criticism for escaping in the lifeboats of the Titanic with the women and children instead of going down with the vessel.

Fairbanks and the Presidency

Indianapolis, Ind., May 11.—Charles W. Fairbanks, former United States senator and vice president of the United States, reached his sixtieth birthday anniversary today. Recently a rumor has been circulated that friends of Mr. Fairbanks plan to present his name for the Republican presidential nomination in the event of a deadlock between Taft and Roosevelt in the Chicago convention next month. So far as is known Mr. Fairbanks has done nothing to encourage the idea. Since his retirement from the vicepresidency he has refrained from any active participation in politics. At the same time the politicians recall the fact that Mr. Fairbanks had a great ambition to head the ticket four years ago many believe that this ambition would be instantly kindled if there appeared to be the slightest chance for its fulfillment. But so far as any outward or visible sign appears, Mr. Fairbanks is far more interested just now in the proceedings of the general conference of Methodists, of which denomination he is one of the foremost laymen in the country, than he is in the contest for the Republican presidential nomination.

State-Wide Spelling "Bee"

Jefferson City, Mo., May 11.—Probably one of the most unique educational events ever held in this country will be the state spelling contest to be held in this city next Monday, the opening day of the annual convention of the Missouri association of county superintendents. At last year's meeting of the superintendents the decadence of spelling was generally deplored and the idea of a state spelling "bee" was hit upon to stir up interest in this particular branch of study in the public schools. Every county of Missouri is expected to be represented in the contest by one public school pupil, who must not be further advanced than the eighth grade. The representatives already have been selected in county elimination contests. Each participant in the state competition will be given fifty words to spell orally and another fifty to be written. The winner of the state spelling championship will be given \$100 in gold. Smaller cash prizes will be given to the pupils who come out second and third in the competitions.

SHRINERS RETURNING.

Final Vaudeville Attractions Tonight to Complete Conclude.

RUBBISH IS VOLUMINOUS.

Street Superintendent Hasn't Started on Carting Stuff Away.

SOCIALISTS TO PICK LEADER

CONVENTION IS MORE THAN ORDINARILY IMPORTANT

BERGER AND SEIDEL CAN'T BE SELECTED

Coming Week Replete With Many Conventions and Political Atmosphere Will Probably Be Cleared Within the Next Seven Days—Socialists Must Decide on Future Policies.

Indianapolis, Ind., May 11.—Leading members of the Socialist party are arriving in this city in anticipation of the national convention which meets here next week to select candidates for president and vice president of the United States and to discuss plans for the coming campaign. In view of the notable gains made by the Socialists in the elections of last year and the prediction that they will poll 2,000,000 votes next November, the coming convention naturally is expected to be the most important that the party has ever held.

In at least one respect the convention is expected to be of extraordinary significance to the party and its future. It will determine the great question whether the Socialists are to follow their old methods of political action or whether they will follow the element represented by the Industrial Workers of the World, which has become impatient of political action and is preaching the doctrine that "direct action" like the recent Lawrence strike will do more for the workers than any amount of balloting.

The divergent views of the rival factions are expected to result in a hard-fought contest for the head of the ticket. Eugene V. Debs, who was the party choice for president in 1900, 1904 and 1908, is not considered in the running this year. The two leaders most widely known, Congressman Victor Berger, and ex-Mayor Seidel of Milwaukee, are barred from the nomination by reason of their foreign birth. Charles Edward Russell, the magazine writer, would be a satisfactory choice so far as the radicals are concerned but probably would be unacceptable to the conservative element. Max Hayes, a very militant labor editor from Cleveland, is an active candidate for the nomination. So is Duncan MacDonald, a well known leader of the mine workers in Illinois.

Washington, D. C., May 11.—Each day of the coming week will add to the number of delegates selected to attend the national conventions of the republican and democratic parties. A complete list of the conventions and primaries slated for the six days beginning next Monday is as follows:

Monday—Republican: The Wyoming state convention at Cheyenne, Tenth North Carolina district convention; Minnesota district primaries. Democratic: Wyoming state convention at Cheyenne.

Tuesday—Republican: California state and district primaries, New Jersey state and district primaries, Tennessee state convention at Nashville, conventions in Third district of Kansas, and Fourth, Fifth and Seventh districts of North Carolina, Democratic: California state and district primaries, New Jersey state and district primaries, Utah state convention at Salt Lake City, New Hampshire state convention at Concord, New Mexico state convention at Clovis.

Wednesday—Republican: Washington state convention at Huntington, the Utah state convention at Provo, North Carolina state convention at Raleigh, conventions in all West Virginia district and in Ninth Texas district. Democratic: Michigan state convention at Bay City, South Carolina state convention at Columbia.

Thursday—Republican: West Virginia state convention at Huntington, Minnesota state convention at Minneapolis, Montana state convention at Livingston, Idaho state convention at Lewiston, district conventions in Fifth Michigan, Second and Fourth Arkansas, and Twelfth, Fourteenth, and Sixteenth Texas. Democratic: Iowa state convention at Burlington.

Friday—Republican: district conventions in Seventh Kansas and First, Second, Third, Fourth, Fifth and Thirteenth Texas. Saturday—Republican: district conventions in Fifth Oklahoma and in the Eighth, Eleventh and Fifteenth Texas.
