ELECTRICITY FOR CAMPERS

CHAUTAUQUA AFFAIRS TAKING SHAPE.

Many Details Gone Over Last Evening by Board of Directors.

With the annual chautauqua's opening day close at hand, directors of the association are bending their efforts toward completion of an enormous amount of detail. A meeting was held last evening when a great deal was done toward making every convenience possible for the guests at the big event. That people are planning on taking up every available space for camping, is evident from the number of inquiries. There will be plenty to go around as a systematic platting will be made to facilitate matters. For the convenience of the campers, steps were taken last night to have electric light wires strung over the grounds so that lights and electric stoves can be operated in the different camps, and extension of the water pipes to other parts of the grounds than the one where the standpipe has always been, was asked for.

The chautauqua's first number is one of the big features and arrangements to handle big crowds the first night are now under way. The fact that the roadway is broken up in front of the park may necessitate the unloading of passengers at the bridge, a condition that would meet with general approval as it would eliminate the congestion at the turnstile and make the drive much safer in every way. This is yet to be decided finally.

For an hour or two on the evening of the Fourth a carnival of water sports will be held, featuring a log rolling contest in which clever performers from local sawmill companies will participate. This unique attraction should be the drawing card for many who have never seen such an attraction.

S. Platt Jones, the man who will take immediate charge of details after they have been worked out by the board of directors, will arrive next week and remain on the ground until after the chautauqua is over.

There are about 80 members of the association to date, and the committee on membership is cleaning up the canvass today. About 100 will be the total membership, it is believed, and the chautauqua management now has an actual body, a tangible existence and should accomplish its objects more readily here after than ever before.
