MEAT WAR REDUCES COST

PACKING HOUSE STARTS FIGHT WITH VEIL

Oregon Cattlemen Are Much Interested in the Outcome.

Cattlemen throughout Oregon are vitally interested in a big meat war which is now in progress in Seattle. One of the big packing houses of that city introduced retail markets and began cutting the price of meat believing that by so doing they could not only reduce the cost of living but at the same time materially increase the consumption. Independent butchers tried to make the packing house cut out its retail markets; the packing house refused with the result that the meat war begun. On account of the high price of beef in the eastern market last summer and fall there has been created in the northwest a scarcity of cattle; cattle which would have ordinarily come to the western market went east. There are not enough cattle to go around. The prediction is made that within a few months local retailers will be compelled to pay a far bigger price for their cattle than were paid by the eastern dealers a few months ago. Certainly the meat war which is now on in Seattle has reduced the cost of living. Meat which a few weeks ago was selling for twenty and twenty-five cents a pound can now be had for ten, fifteen and twenty cents. Never in the history of the city has so much meat been sold as during the past two weeks. There is no indication that the war will soon end; on the contrary there is every indication that it will continue for six months.

Railroad Carpenter Killed.

(Pendleton East Oregonian.)
Death beneath the wheels of a freight engine was the fate met by William M. Lamson, a railroad carpenter, last evening about 6:30 at Gibbon. While walking from his bunk car to the station in order to purchase a newspaper from No. 6, engine No. 524 of freight No. 23, Engineer Bert Anderson and Conductor B. Carney, came backing down the sidetrack No. 8 and though the brakeman called warnings to him, he did not clear the track in time to keep from being struck. He body fell beneath the wheels of the engine and was horribly mangled, death being instantaneous.

Acting Coroner Joe H. Parkes conducted an inquest this morning and the verdict exonerated the railroad company, the evidence showing that the deceased was walking along the track in the open and of his own volition and had a full view of the switch engine. The principal evidence was given by Foreman G. M. Ring. Lamson was a man about 55 or 56 years of age and his home was at The Dalles at 1262 Vine street. He leaves a widow and three daughters. The widow is here today to take charge of the body and will have it shipped to her home this evening.

According to the testimony at the inquest, Lamson had been working for the O. W. R. & N. company about six months as a bridge carpenter and recently had been stationed at Gibbon.

"Movies" of the big construction work are to be exhibited in capitol committee rooms this winter, to illustrate graphically the necessity for appropriations. Fortification plans will also be illustrated in the pictures. Secretary of War Stimson, by a peculiar coincidence, is also inspecting the canal work while the House committee is looking over the project. A considerable part of the Secretary's annual report to the President this winter is to be devoted to the canal, as the Taft administration's "last word" on Panama.
