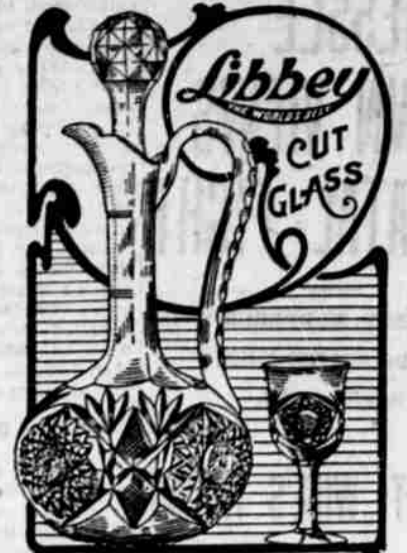
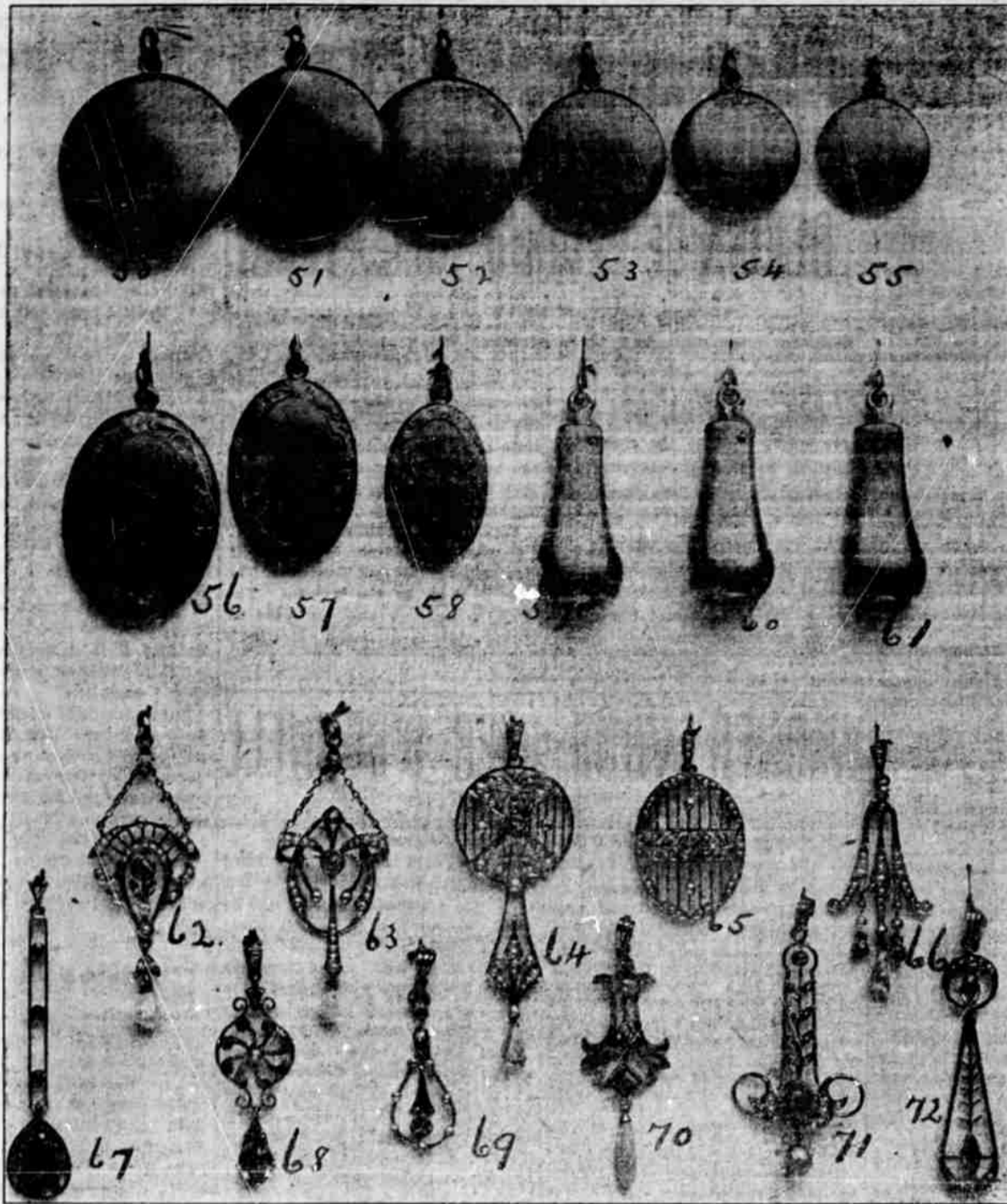

Notice of the recorder of the city of La Grande, Oregon, of the assessment of improvement district No. 27 of the city of La Grande, Oregon.

Notice is hereby given that the assessment for the improvement of North Second street, being improvement district No. 27 of the city of La Grande, Oregon, under the provisions of Ordinance No. 679, Series 1912, entitled, "An ordinance declaring the cost of improving North second street from the north property line of W avenue to the center of Lake avenue, determining the property benefited hereby; levying a reassessment thereon to defray the costs of the improvement; providing for the assessment roll of the same and directing the entry of said assessments in the docket of city liens; providing the time when the same shall become delinquent; and requiring the city recorder to prepare a special assessment roll in accordance with the assessments herein levied and to collect said assessments, the same being in improvement district No. 27, in said city of La Grande, Oregon, is now in my hands for collection and that any installment therein may be paid to me at any time within ten (10) days from the 19th day of December, 1912, without penalty, interest or cost; and each property owner is hereby notified that on application to the undersigned within ten (10) days from the 19th day of December, 1912, which is the first date of the publication of this notice, they will be allowed to pay such assessment in ten (10) annual installments, the first installment thereof being due and payable on or before the 19th day of December, 1913.
