\$100,000 Suit for Legless Boy.

Sumpter, Ore., Jan. 16.—(Special)—Considerable interest is manifest here over the announcement that Wm. Mortisen, father of La Vaughn Mortisen, 10 years and are well known and for the Baker circuit court for damages against the Columbia mine in the Cracker Creek district. Mr. Mortisen and family have made their home in this vicinity for several years and are well known and for this reason the outcome of the case will be watched by Sumpter residents with interest.

New Water System for Baker.
(Baker Democrat.)

The question of completing the present city pipe line by building a new main from the settling tank to the reservoir, and the new line to connect Marble, Mill and Goodrich creeks with the present supply, including a new dam on the latter stream, at an approximate cost of \$150,000, will probably be up to the taxpayers of the city to decide in the near future. An ordinance covering the whole matter, including the bond issue, was ordered drawn by the city attorney on the passage of a resolution to that effect by Commissioner Henry at a meeting of the board yesterday.

The improvement is strongly recommended by Mr. Henry and endorsed by the mayor and Commissioner Finley, as well as by all citizens who know the conditions of the line at present. The new portion of line completed last year lacks efficiency until the work is completed, and the completion of the same means that Baker's water supply will be the most abundant and handled by a plant equal to any in the northwest.

The proposed improvements would result in a line capable of delivering water into the city mains at the rate of 2750 gallons a minute, and would give 400 horsepower at the distributing reservoir for the operation of a municipal light plant at any time as the city might see fit to build. In order to get the improvements through the present season,
