### Quarters for Athletes.

### Hood River May Lose Library.

Hood River, Or., March 5.—Hood River city may lose the \$17,500 Carnegie library. The Carnegie foundation demands security for the annual payment of \$1750 for the maintenance of the library before the donation will be awarded and it has refused to take the city for the amount.

The county will guarantee the maintenance fund only on condition that the city secure additional ground for the library site.

The city charter does not provide for the issuing of park bonds and several members of the council are opposed to the amending of the charter, as it will throw down the bars to promiscuous expenditures. An effort will be made to take money from the general fund to buy land for the park extension and it is reported that the city will be enjoined from so doing, as this would not be legal.

It is said that the women will invoke the initiative as a last resort to call an election to amend the charter, so as to be able to vote park bonds.

### Swimming Hole for Boys.

Spokane, Wash., March 7.—With the purchase by the park board of eight lots costing \$11,500, and assurance from Olympia that the legislature will pass a bill donating the Spokane river bed to the city, the small boys are gleeful because they will get a new "swimmin' hole." ## O. A. C. TREAT ON MAT NEAR

### LOCAL STUDENTS TO COMPETE AT O. A. C.

Reynolds and McKinnie in Wrestling Teams This Spring.

Oregon Agricultural College, Corvallis, Ore., March 6.—(Special.)—"Eskimo" Hurst of Sitka Alaska, will vie with H. Pearcy of Portland, a younger brother of Knight Pearcy who held the northwest championship for honors in the 115 pound class in the freshman entries at the Oregon Agricultural college this spring. He is "husky", but will have to put up a good fight, for Pearcy has been doing excellent work at the Multnomah club, and has had the benefit of his brother's tutelage.

Hardman of Ontario will represent the sophomores in the same class, E. C. Potter of Portland the seniors, and Paul Freidig of Sutherlin, winner of the 115 pound place on the team last year, it is thought, will, in the end, have to meet young Pearcy.

Four men are out to try to take the 125 pound place on the team away from Amort of Albany, three of them freshmen—Reiman of Pasadena, California, Lewis of Portland and Bennett of Dallas. "Shrimp" Reynolds, snappy football quarter, is the senior who is expected to meet Amort in the finals.

Since Knight Pearcy is gone from the 135 pound class, the eight candidates all have a chance to be the new man. Five of these A. Schreiber, Mason Farmer, Cramer and Bridges, are freshmen, two are sophomores, Millikin of Ontario and Pelland, Corvallis, and one junior, R. R. Davis, Hillsboro.

Entrance for the 145 pound position, five in number, will have a hard row to hoe, as they must meet the northwest champion of last year, captain of the wrestling team, John Kelley of Jefferson. The brave quintet are Hawkins and Morley, freshmen, and three juniors, F. W. Schreiber of McMinnville, C. C. Caylord of Carson and J. B. Hukill of Corvallis. It is thought Hawkins, who is from Bellingham, Wash., may prove the best of the five.

Two old men and three new ones are to fight for the honors in the 150 pound class, Baynard, a junior from Silverton, and L. R. McKinzie of Summerville taking on the three novices, Waller and Allworth of Battle Ground, Wash., freshmen, and John Muckman, sophomore from St. Johns.

### Street Work Pay Raised.

Washington, March 6.—Among the provisions in the District of Columbia

appropriation bill this year is a senate amendment put in by Senator Works, of California, requiring that street laborers be paid at least \$2 per day. All of these laborers are colored.

### Want Citrus Protected

Washington, March 6.—Rep. Kettner, of San Diego, is making no false pretenses on the tariff situation. Though he is just now becoming a real member of the House he has been doing the routine work of the late Rep. Smith's office for the past two months, and is pretty well disillusioned.

"The plain fact is", he said today, "that every member here is favorable to placing on the free list everything but the products of his home district. I am in the same boat, though I am more liberal. I ask merely that the citrus products of my district be given their share of the tariff which must be retained in order that sufficient revenue shall be raised to meet our national expenditure."

Kettner's constituents have been wondering what success he would have in convincing Oscar Underwood that lemons and oranges could not stand a tariff cut. He has learned that some cut will surely be made.

### Ore on Mountain Tops

Washington, March 6.—Iron ore deposits at the summits of the Sierras near Ninaret, Wadara county, California, are perhaps among the largest in the west, according to the United States Geological survey bulletin. They are not yet valuable because they are too far from the fuel necessary for smelting.

Less extensive but more valuable are the iron ores in the Eagle mountains in Riverside county, the southern desert. They have just been surveyed and mapped, and a chain of discontinuous deposits, six and a half miles long, is now known to extend across the summit of the range on the north limb of the dome. The government investigator estimates the ore to amount to about 60,000,000 tons, mostly high grade.

Development of these ores depends upon the opening of the Alaska coal fields and the cheap transportation of that fuel to California ports, where blast furnaces and steel plants will be established.
