## SIX LAWYERS GIVEN PERMITS

SUPREME COURT AT PENDLETON QUIZZES ATTORNEYS.

Various Cases from Eastern Oregon Heard Before Tribunal.

Pendleton, May 7.—The East Oregonian says: Six new lawyers were created today by the Oregon supreme court in session here. Every one of the applicants who took the bar examination succeeded in qualifying and are now admitted to practice. They are Edward B. Williams of Redmond, Jacob M. Blank of Canyon City, William Dick of The Dalles, James Raymond Murphy of Metolius, and John R. Wheeler of Vale.

The first case to be argued and submitted before the supreme tribunal today was the murder case from Harney county, the State vs. John M. Taylor. Deputy District Attorney Swagler of Vale appeared for the state and Mark Weatherford of Albany for the appellant.
