gon cases and on Tuesday, November 4, Federal Judge R. S. Bean will open court in this city.

Assistant Clerk Lee Moorehouse's docket shows that here are 22 cases to come before the supreme court at the session next week but of that number Umatilla county contributes only one. The long fought case of Bergevin Bros., vs. Matt Mosgrove, is the second one on the docket. Bergevin Bros. are the appellants and they are represented by D. W. Bailey and R. R. Johnson, while the respondent's counsel consists of R. J. Slater, Ralley & Ralley and James A. Fee.

The entire court, consisting of Chief Justice Thomas A. McBride and Associate Justice Frank A. Moore, Henry J. Bean, Geo. H. Burnett, Robert Eakin, William M. Ramsey and Chas. L. McNary, will be present. This will be the first visit of Justices Ramsey and McNary, they being the newly appointed members of the court.

Columbia George Trial. The principal case to come before the federal court is the murder case the defendant of which is Columbia George, the notorious Indian, who, it is alleged, struck down Timot, an aged squaw, on the reservation more than a year ago. The government has worked up a strong circumstantial case against him but the defense will make a hard fight to save him from the gallows. Col. J. H. Ralley is counsel for the accused.
