PAST WEEK HAS BEEN SEVERE ONE AT ELGIN.

Lumbermen Welcome Snow But Lumber Cut Will Be Curtailed.

Elgin, Ore., Feb. 7.—(Special).—Winter reigns supreme. Elgin lies buried under 14 inches of perfectly good, loose, soft, white snow. Elgin was hit with a blizzard Sunday and the latter part of last week, which was followed up by a cold snap, the mercury falling to seven degrees below zero Monday night, while on Wednesday still lower—10 degrees.

The snow, which until last week had fallen very lightly, is certainly "sticking" now for the loggers, who are working full crews. Although the prospective lumber cut this year will be comparatively small to that of last year.

NOTICE is hereby given that the assessment for the improvement of Section No. 4 of Sewer district No. 1, of the city of La Grande, Oregon, under the provisions of Ordinance No. 764, Series 1914, entitled "An Ordinance declaring the cost of constructing an 8-inch lateral sanitary sewer in section No. 4 of district No. 1, along the center line of the blocks lying between Walnut street and Alder street, from the center line of Jefferson avenue to the center line of "O" avenue, and along the center line of the blocks between "O" avenue and Walnut street from the center line of Pennsylvania avenue to the center line of "O" avenue and along the center line of the blocks lying between Cedar street and Oak street from the center line of Spring avenue to the center line of "O" avenue and along the center line of the blocks between First street and Cedar street from the center line of Spring avenue to the center line of "O" avenue and along the center line of the property line of Pennsylvania avenue; determining the property benefited thereby, levying an assessment thereon to defray the costs and expenses of said improvement; providing for an assessment roll for the same, and directing the entry of said assessment roll in the docket of city liens; providing a time when the same shall become delinquent, and requiring the city recorder to prepare a special assessment roll in accordance with the assessments levied herein and to collect thereon—Spa hhh herein, and to collect such assessments, the same being the improvement of section No. 4 of sewer district No. 1, in said city of La Grande, Oregon, is now in my hands for collection and the same may be paid to me at any time within (10) ten days from the 4th day of February, 1914, without penalty, interest or cost; and each property owner is hereby notified that on application to the undersigned within (10) ten days from the 4th day of February, 1914, which is the first date of the publication of this notice, they will be allowed to pay such assessment in ten (10) annual installments, the first installment thereon being due and payable on or before the 14th day of January, 1915.

If application is not made as above specified, the whole amount is due payable and will become delinquent on the 16th day of February, 1914:
