Notice is hereby given that the assessment for the Improvement of Cedar Street, being improvement District No. 60 of the City of La Grande, Oregon, under the provisions of Ordinance No. 755, Series 1914. "An Ordinance declaring the cost of Improving Cedar Street from the South line of Main Avenue to the North line of Spring Avenue, by grading said street; determining the property benefited thereby; levying an assessment thereon to defray the cost and expense of said improvement; providing for an assessment roll of the same; directing the entry of such assessment roll in the Docket of City Liens; providing a time when the same shall become delinquent; and requiring the City Recorder to prepare a special assessment roll in accordance with the assessment levied herein, and to collect such assessment, the same being in Improvement District No. 60 in said City of La Grande, Oregon, is now in my hands for collection and the same may be

paid to me at any time within ten (10) days from the 26th day of February, 1914, without penalty, interest or cost; and each property owner is hereby notified that on application to the undersigned within ten (10) days from the 26th day of February, 1914, which is the first date of the publication of this notice, that they will be allowed to pay such assessment in ten (10) annual installments, the first installment thereof being due and payable on or before the 18th day of February, 1915.
