COURT URGES FAMILY PEACE

DIVORCE REFUSED TO PARENTS OF INFANTS.

Judge Knowles Advises Quarreling Family to Make Peace.

Circuit Judge J. W. Knowles last evening laid down some vital principles for quarreling families with children when he denied a divorce to Nellie Walls from Lewis Walls.

The case had occupied two days and ended with a denial of divorce and some admonition to the principals in the case. The parties have two infant children, one a baby of about 10 months and the other, but little older. The plaintiff alleged cruel and inhuman treatment but the court found insufficient evidence to justify decree of divorce. Judge Knowles in refusing the decree held that where parties have brought children into the world that these children should also be considered and that the

home should be protected first and the sanctity of the marriage vows not lightly cast aside, especially so when the father and mother have minor family difficulties only.

The defendant expressed the desire that his wife return to him and the court earnestly urged the parties, by reason of their obligation to their children, to endeavor to cast aside difficulties and "Join hands again for the sake of the children." Attorney R. J. Green handled the defendant's case.

were able to occasionally quote low prices on standard goods of well known makes he has to say: "Catalog houses as well as other large merchants, often have opportunities to purchase at reduced prices what is known to the trade as 'job lots.' A factory may discontinue the manufacture of a certain style, and having a large stock of that particular pattern on hand, will offer the entire lot at cost or even less, while of course such merchandise is of standard quality, it naturally must have lost its desirability in the eyes of the critical consumer, otherwise there would be no reason for discontinuing the manufacture of it. With this exception, and the occasional opportunity they have of purchasing bankrupt factory stocks, the arguments and facts as presented are incontrovertible."
