## COVE ENJOYS FARM SCHOOL

TWO HUNDRED FREQUENTLY IN ATTENDANCE

Week's Activities in that Line Reviewed by Correspondent.

Cove, Feb. 15.—The Farmers' Institute and Home-Makers' school closed at Cove Saturday afternoon, after a week's very popular lectures. All the meetings were well attended by farmers, townspeople and school children, the high school being dismissed for the meetings, which added very materially to the total attendance. Probably no one showed a keener interest in the lectures than did a number of the high school students. Many of them kept note books and pencils busy at every lecture.

The evening meetings were especially well attended, which proved the popularity of the illustrated lectures. The evening programs were interspersed with selections by local talent. Male quartettes, solos, orchestra music and readings, all helped to make the evening entertainments both instructive and enjoyable. The total attendance for the entire week, was about 2500, a showing which will undoubtedly mean another institute at Cove next year.

Monday morning Robt. Withycombe in an instructive and interesting discussion on "Hog Feeding" pointed out the relative value of different feeds, information of interest to every farmer who feeds hogs. R. E. Reynolds followed with a lecture on "Sheep on the Small Farm." In the afternoon a large interested crowd listened to C. N. Kennedy as he showed "How to Detect Unsoundness in Horses," and the horse judging which followed evoked a lively interest. The evening lectures were attended by about 200.

Tuesday morning seventy-five persons stood out in a lively rain as R. E. Reynolds discussed "Market Types of Hogs," and "Hog Judging." Tuesday afternoon Prof. E. B. Fitts' lecture on "Care and Management of the Dairy Herd," an able discourse, and brought out many points of interest to all interested in dairy cow. He was followed by M. S. Shroeder's evening lecture was a feature well deserving of the praise heard on all sides.

Wednesday morning, a packed house greeted the speakers and in the afternoon Mr. Kehrl gave a milk the afternoon demonstration which was followed by the cow-judging demonstration by Prof. Fitts. Two hundred and two people at one of the most noteworthy features of the institute. Prof. Fitts proved himself a capable and instructive dairy judge. A work and probably the most interesting of the institute was the lectures of demonstrations as handled by Prof. J. E. Larson, on "Soils," "Tillage" and "Legumes." All his lectures were interspersed and followed by many questions from the listeners, and the scheduled time allowed Prof. Larson was always far too short. Mr. Cate, our County Agriculturist, gave interesting talks on "Weeds," "Clover Seed Production," and led a live discussion on "Clover Practice in Orchards."

Friday afternoon and Saturday were devoted to poultry and horticulture, C. C. Lamb and Prof. Brown heading the discussions. Keen interest was shown in Mr. Lamb's work, and his illustrated lecture Friday evening brought much praise on every hand, as did also Prof. Brown's on "Insect and Diseases." Saturday morning Prof. Brown took up the big subject of "By Products," and handled it in a masterly way, pointing out the benefits of co-operation, and the obstacles to be overcome in organization and co-operation. His pruning demonstration was all too short, but he was able to give many of the fundamental principles of pruning and training of fruit trees, all of which was closely followed by his listeners. Pruning of the cherry held much of interest, as recent planting of this famous Cove fruit have been quite extensive.

From start to finish the Farmers' Institute was a complete success and every member of the instruction staff will be welcome in Cove at the next institute.

### BIG DAMAGE WANTED.

Pendleton Banker Sued for \$30,000 After Automobile Accident.

Pendleton, Feb. 16.—As guardian of his 9 year old son, Sharon Arnold Twitchell, L. E. Twitchell of this city today filed action for \$30,000 damages against W. L. Thompson, president of the American National Bank, for injuries sustained by his son in an accident last summer caused by a collision of the boy's bicycle and Mr. Thompson's auto. Judge Bennett and his partner, Francis Galloway, of The Dallas, and Fee and Fee of this city are attorneys for the plaintiff in the suit.

Plaintiff alleges in his complaint that the defendant was driving his big auto at a speed exceeding the limit prescribed by the city ordinance and that he was on the wrong side of the street at the time of the accident. The accident occurred on July 23, 1914 on Lee street between Court and Lewis. The boy was riding north on Lee and the defendant drove his car, in which were several other people, from Lewis into Lee street. The boy sustained a fractured skull in the accident and was confined to the St. An-

thon's hospital for several weeks. For some time it was thought he could not live, eventually he improved to such an extent that he was able to go home.

Not only did he suffer great pain but his mind, body and memory will be affected always, according to the allegations of the complaint. He is still partially paralyzed, it is averred.

Prior to the filing of the suit, Judge Phelps appointed the father of the boy guardian ad litem in order to permit him to represent his son in the action.

### Big Shortage Not Found.

Baker, Feb. 13.—The shortage in the office of the county treasurer which was reported by C. M. Lockwood, special state accountant at \$1223.09 failed to materialize in the audit of the county books which has been conducted since January 4 by C. H. Whitney and Davis Miles, expert accountants. Instead the accountants found the books to have been well kept and so have stated in their report to the county court.

A shortage of \$8.80 was discovered in the entire audit and these were found to be due to clerical errors, all of which were checked and straightened out. The complete report of the accountants will probably be made today.
