**MANY ATTEND FROM UNION
COUNTY LODGES.**

**Enterprise Hosts Spring Something
New Every Minute of Session.**

Enterprise Lodge Knights of Pythias was a fine and dandy host Saturday evening to all Knights of Pythias lodges in Union and Wallawa counties at the annual district convention. In many respects no Pythian gathering in the past has been so significant as this one was.

The La Grande and Union delegates returned on a special train yesterday morning, arriving here shortly after 8 o'clock. It was a grand old night and many grand old knights were on hand to enjoy it. The train was an hour late reaching its destination but the program had simply been moved ahead to fit the occasion. Enterprise lodgemen stopped at nothing to entertain their visitors, and a goodly number they had to entertain.

Fifty-two, including the grand lodge officers who were in attendance, and a few from the Union lodge, boarded the special at La Grande, 89 got on at Elgin, 30 at Wallawa, and the regular Enterprise membership of about 100 made up the attendance at the convention.
