ing at Negro's head, landing several times. They mixed in the center of the ring; Johnson landed left jab to body, and drove Willard to the ropes. Willard blocked left to body and a right to jaw. Round even.

Round Four. Johnson came out laughing, holding out his stomach, but Willard failed to fall for the trick that helped Johnson whip Jeffries. They clinch and there was a sharp engagement in the breakaway, but no damage to either. Both blocked lefts and Willard blocked another of Johnson's attempts to rush. Johnson rushed Willard into the ropes, landing two hard punches. At end of round Willard bled slightly around lips. Johnson's round.

Round Five. Johnson sent right to body, and a left to Willard's face. In a mixup in center of the ring, Johnson emerged bleeding slightly; they clinch. Johnson again rushed Willard to the ropes, landing two body blows, and Willard sent left to Johnson's face. Even round.

Round Six. In an exchange of blows, Johnson landed a stiff right to jaw. Willard blocked several left jabs directed at the body. Johnson rushed, fighting fiercely, and raining blows to the white man's body. Willard seemed cool, and landed a hard left to the jaw. Johnson drove Willard into a corner, at bell. Round even.

Round Seven. Johnson was fighting in this round with grim determination, while Willard was dodging some vicious belly blows and gave the Negro some right and left jabs to the face and several hard body blows, in the break from a clinch. It was Willard's round.

Round Eight. Fighting is fierce. Willard is aggressive and landed a right to the head that rocked the Negro. Johnson clinched, holding on. Fierce exchange Willard had all the best of it, raining blows to the Negro's head and body. Johnson looked weary during the fast and furious milling and was puffing badly. Just before the bell he again tried to rush Willard, but again was blocked. Willard's round.

Round Nine. Johnson, for the first time in his ring career, is now rushing wildly about and is visibly tired. Willard continues to block every swing and is fighting with confidence, but is cautious. The fighting in this round was easily Willard's again.

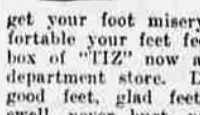
Round Ten. Willard landed left to jaw, and blocked Johnson's rushes. There was a mixup in the center of the ring, with no damage. Johnson landed left to the body. The round was tame and even.

Round Eleven. Johnson is tiring but continued smiling and began to kid the white man. Willard was not intent to rush matters, but is now waiting to wear Johnson out. There was an even ex-

change of body blows but no damage done. Even round.

Round Twelve. Willard is bleeding from right ear. Johnson landed left to body, then a right high on head; The white man sent right to body; Johnson tried a left to jaw but was blocked, and Willard stopped a right headed for the same place. Willard had the better of another mixup in which at least a dozen blows were exchanged. Johnson rushed Willard to the ropes, scoring heavily; he landed lefts and rights to the Kansan's face. Willard landed left to Johnson's face as the round ended. Johnson's round.

Round Thirteen. Johnson apparently was fresh, and rushed to Willard again, raining lefts and rights, but the Kansan blocked him successfully; Johnson came on again, and Willard found himself in a whirlwind of blows; the Negro landed left to the body, and another left was stopped; Johnson hooked a stiff left to the jaw. This was the Negro's best round. Johnson's round.

Round Fourteen. Willard began rushing the fighting. He carried the battle to the champion's corner and landed lefts and rights to face; Johnson scored with left to the body and clinched. The round was tame, both fighters hanging on much of the time. Round even.

Round Fifteen. Johnson rushed, but two of his hay-makers slid harmlessly off Willard's guard; they clinched; Willard missed again; in this round he is kidding and joshing Willard and his friends. Willard blocked several leads before they were well started. Round even.

Round Sixteen. Willard sent another jab to the ribs; Johnson countered with another shower of blows, but Willard blocked them all and clinched. Willard aggressive, but the Negro blocked vicious lefts to body. Johnson rushed Willard to the ropes with a number of smashes to the head and body; they clinched at the bell. Round even.

Round Seventeen. Both clinched at the start; the Kansan landed right to the body, then rushed champion nearly to the ropes, sending two rights to body; Johnson answered with left jab to jaw; champion shot left and right to body. Willard had all the better of a lively exchange of blows just before the bell ended the round. Round even.

Round Eighteen. Johnson looked good at the start of this round. He landed right to the body and swung four times at the white man, but Willard ducked his head out of the way. Johnson landed hard left to jaw that rocked the Kansan's head; Willard countered with a smashing right to the body, and followed this with a straight right to the head. Round even.

Round Nineteen. They stalled and clinched early in this round. Both fighters blocked several swings. Willard carried the fighting to Johnson, landing right to the stomach and a light tap on the face; Johnson hooked a short left to the body; there was a lively exchange with both men showering blows, and the big Kansan getting the better of the mixup. Willard's round.

Round Twenty. Willard took the aggressive and rushed the Negro toward his corner; Johnson blocked several leads to the face. Johnson was trying to lead the cowboy to a trap; there was a fierce mixup in the middle of the ring; Willard blocked most of the Negro's punches and landed his right repeatedly, in the mixup. Willard's round.

Round Twenty-One. Willard shot a right to the head, and the blow evidently bothered the Negro, as he clinched and held on. During the infighting Willard scored again, landing several jabs to body and a light swing to the head, as he broke away. This was another tame round, but replete with hippodroming. Willard's round.

Round Twenty-Two. The Kansan blocked a vicious right and jabbed a stiff left to the jaw; they clinched and wrestled in the middle of the ring, and Willard landed three hard blows to body in the infighting. Willard landed right repeatedly to Johnson's stomach, and the Negro rushed into a clinch to save himself, holding on until the bell. Willard's round.

Round Twenty-Three. Johnson blocked two rights to the jaw; white hope sent in hard rights and lefts, but Johnson blocked them all. Willard was doing all the fighting in this round, the Negro apparently pushing the white man to wear out, if possible. Willard scored a light left to the face, and the champion grinned. Willard's round.

Round Twenty-Four. The champion was patiently resting at the beginning of this round, holding on to Willard, and passing winks to his seconds. The white man hooked a left to the body; they went into another clinch, and for the greater part of the round, hugged like a couple of wrestlers. There was little fighting. Willard scored three lefts to the jaw. Willard's round.

Round Twenty-Five. Willard rushed in and sent a light

Round Twenty-Six. Willard landed right to the body. Referee Welsh was forced to make Johnson break. The Negro hung on from the start. Willard nearly dropped the Negro with a terrific left to the jaw. Johnson was nearly gone then. He clinched and hung on, but Willard sent in a final smash that knocked the champion cold.
