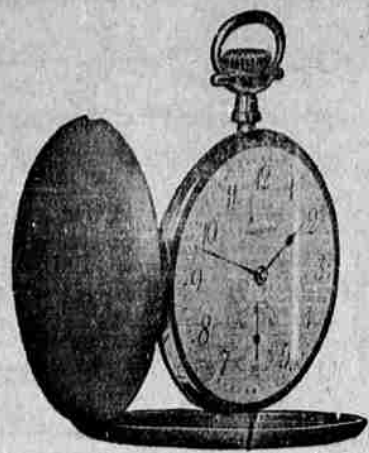

MONEY TURNED INTO COUNTY

HUNTERS AND FISHERMEN
SPEND \$3674 IN YEAR.

Next Year Greater Returns to the
County Will be Realized.

Since May 21st this year, when the new law went into effect, Union county has realized \$117.25 from the sale of hunting and angling licenses. As the year's end approaches, County Clerk Ed Wright has struck totals for the year and finds that Union county sportsmen contributed \$3674 to the state and county coffers. Of this amount five percent remained here— with deduction of the winter months prior to effectiveness of the law— and the rest went directly into the state sportsmen's fund which is a self supporting institution.

Next year, it is argued, this amount will be considerably larger as the full 12 months will be available for the five percent.

This year's sportsmen's licenses were slightly under a year ago. In 1914 the sale was:

The current year's figures read:

Hunters'	1499
Anglers'	1879

The new licenses are now on hand and within a few days will be on sale at the usual places throughout the county. A ruling in this connection goes into effect for the new year. Old soldiers from the civil war, Confederate or Northern, can obtain free licenses by showing honorable discharge papers or pension rights, but this must be done with the county clerk only.

Enforce Vital Statistics Law.

Baker, Dec. 20.—Under the new model law for the better registration of vital statistics in Oregon, which is effective the first of the year, City Health Officer Dr. Huff and County Health Physician Dr. Patterson, as the delegated officials, have named Sumpter, Haines, Huntington, Halfway and Richland as the registration centers for Baker county, where they will appoint registrars to attend to

the business. These officers, in addition to attending to the registration of vital statistics, are to make reports on deaths where no physician is in attendance, and if necessary order an inquest by the coroner. The registrars will be named in the near future.

Until recent years the United States of America has been deficient in possessing a uniform system in the registration of births and deaths. This has caused great surprise in European countries, where uniform registration systems have been in vogue for many years. Of late years there have been an increased number of states that have adopted a "Model Law," or an act making registration of births and deaths compulsory by law. The people of the state of Oregon will derive many facts and for their material and physical welfare with the enactment of this bill.

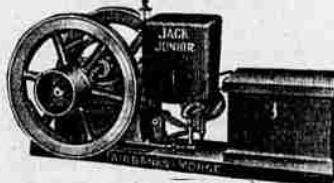
