MAY DESTROY BEER SUPPLY

BAKER BREWER HAS QUEER PROBLEM TO SOLVE

Revenue Officer. It Is Expected, Will Empty Kegs.

Baker, Jan. 10.—The equivalent of 400 barrels of bottled beer now stored in bulk in the brewery of the American Brewing & Crystal Ice plant in Baker, amounting to 7200 gallons, will in all probability be poured into the sewer whenever a revenue officer arrives in Baker, according to Charles Bodeau, manager of the works.

"We have found it impossible to use machinery from the Sam-O bottling plant," Mr. Bodeau said this morning, "and while the beer could be shipped out of the state in bulk we would have to undersell the domestic beer of whatever state we shipped to, eliminating the possibility of profit. The beer will probably be poured out, and listed as a total loss."

Mr. Bodeau's decision is the result of the fire of Sunday morning, when the brewery bottling plant was gutted by fire and the machinery housed there, ruined.

The brewery manager was unable to say what use the main plant will be turned to. "I'm completely up in the air as to that phase of the question," he admitted.

FARM SALES ARE RECORDED

BOTH LARGE FARMS LOCATED IN IMBLER DISTRICT.

Wm. Osborn and W. R. Ledbetter Are Purchasers of Land.

Two large farm sales have been consummated near Imbler the past few days. Wm. Osborn who was formerly a Grande Ronde but for the past twelve or more years has been farming in Umatilla county has purchased 200 acres of the Garns estate near Imbler. The place is well improved and a splendid farm. Mr. Osborn has taken possession.

Saturday W. R. Ledbetter, the well known Alicel farmer, horse grower and all around booster took title to the 160 acre farm, known to pioneer readers as the Samuel Cochran farm near Imbler, but purchased five years ago by Colorado bankers who set it all out to commercial orchard. Mr. Ledbetter has had 120 acres of the trees pulled and will pull the balance this spring and seed it all in wheat. This tract is situated just one mile north of Mr. Ledbetter's home. Geo. H. Currey negotiated the sale.

Mr. Currey reports considerable inquiry for real estate and looks for an increase in the number of sales during the coming year. He observes however a tendency on the part of prospective purchasers to demand close values figured on a business basis. The old speculative spirit based on probable increases in land values has disappeared, and sales are

now being figured on a production basis.

Alleged Blackmailers Are Indicted.

Baker, Jan. 8.—Among the indictments returned by the grand jury were true bills against James Pruitt and Blanche Pruitt, charged with extortion. According to the testimony before the grand jury, they threatened to bring charges of violation of the Mann act against Dr. H. E. Currey unless he paid them \$3000. Mrs. Pruitt was formerly Dr. Currey's stenographer.

According to the bill of indictment, Mr. and Mrs. Pruitt threatened Dr. Currey that they would show that he brought Mrs. Pruitt, then Blanche Greves, to Baker for immoral purposes unless he paid them the money. This Dr. Currey refused to do and lodged information with the district attorney that led to the indictment. The Pruitts are not now in Baker and whether or not effort will be made to bring them here for trial has not been announced.

town of this student are withheld, but here are his sentiments:

"I realize that with a college education my conscience might interfere with my life's ambition. These ambitions are to get riches, no matter by what method; to secure fame, even at the cost of a million souls; to trample upon the faces of the poor and make the rich bow before me. In the realization of these ambitions, I need a callous conscience and a slumbering pity."

The student then remarks that he understands the main purpose of higher education to be the instilling of culture, the development of character, and cultivation of social usefulness in young men and women.

"By so doing it is claimed the university benefits society as a whole, which claim seems founded upon substantial facts," he writes "College men and women have a broader and deeper view of life, so that social service appeals to them."

"But it appals me," he protests. "The higher education might cause some virtue to be inculcated in me that might perhaps cause a guilty conscience to prick me. Therefore, I say, I must avoid such a deterrent." He thereupon withdraws from further study.

PAROLED MEN MAKING GOOD

Report Submitted to Governor Shows 94 Per Cent.

In a report submitted to Governor Withycombe by Joseph F. Keller, state parole officer, it is shown that up to the first of the year ninety-four administration. Of these twenty-two men were paroled under the present law and nine have violated their paroles and of these violators seventeen already have been returned to the penitentiary. Three violators committed crimes in California and are now serving terms in San Quentin penitentiary.

Mr. Keller places the distance traveled in returning parole violators at 14,178 miles, and the railroad fare and expenses incurred in returning parole violators, escapes, and miscellaneous work at \$1507.

During the holiday season Governor Withycombe addressed a personal letter to each one of the sixty-five men paroled by him who are in good standing. A large percentage of replies have been received by him, in which the men state what they are doing and how they are getting along.

In his letter the governor made it clear that his expectation and hope was for each paroled man to "make good," pointing out that the success of the parole system and the opportunity of prisoners to enjoy its privileges depended in a very great measure upon the actions and records of the men who had been released.

MAY BE COAL SHORTAGE.

Less Anthracite Produced, and Car Shortage May Have Effect.

Washington, Jan. 10.—The output of anthracite coal in the United States in 1915 was approximately 79,100,000 tons, as against 81,090,000 tons in 1914, according to a report to the Department of the Interior by the Anthracite Bureau of Information at Wilkes-Barre, Pa. Practically all of the anthracite was mined in that State.

Of the 1915 output, over 66,000,000 tons were shipped to tidewater. The public, the report says, has been rather shy in laying in coal, and the companies have had to store immense quantities near the mines, which may cause a coal famine before spring in case the car shortage continues and hard weather sets in.

AN ALBANY PIONEER.

Came to Oregon in 1851 and Was 93 Years Old.

Albany, Ore., Jan. 8.—Nimrod Price, Linn county's oldest citizen, died at 6 o'clock last night. He was a man of splendid character, a good citizen and kind father and husband.

Nimrod Price, son of James Price and Drusilla Morgan, was born at Louisville, Kentucky, September 9, 1822. Through his father's family he was closely related to General Sterling Price, the Confederate general, and on his mother's side was directly descended from the noted Morgan family whose ancestors founded the city of Morgantown, West Virginia.

While a youth, his parents removed to Vincennes, Indiana, and from there to Danville, Illinois, where he attained his majority and where he married on October 22, 1846, America Froman, who died October 30, 1898, after 62 years of wedded life. He was one of Oregon's early pioneers, leaving Danville, Illinois, in March, 1851, with his wife and two infant sons and other members of family and starting for the Willamette valley in an emigrant train. Six months was consumed on the way, amid privations and hardships, but on his 29th birthday, September 9, 1851, he reached Foster's, coming over the Barlow road and was there met by a representative of the Oregonian, for which paper he subscribed and ordered it sent to Albany, Oregon. He stopped for a time in Marion county with his family, but spent the first winter on the Santiam in Linn county, moving upon the Donation Land Claim of himself and wife in March, 1852. This home was a land mark; his house the first was known to all the old settlers for platted house in Linn county, and many years. After a residence there

of 60 years, broken by intermittent residence in his town house at Albany, where the family lived during a number of years for purposes of school education, he removed to Albany in 1912 and has since resided there with his son, Clarke Price and wife.

arrested and later Mrs. Mohr was taken into custody. Brown is said to have admitted firing the shots at Dr. Mohr while Spellman told the authorities, they say, that he shot Miss Burger.
