LA GRANDER HATES VILLA

J. E. DAVIS WOULD SERVE AGAIN IN REGULARS

Three Years Spent in Border Disputes Whets American for More

Some close-range study of the Mexican's way of doing business is given in an interview with J. E. Davis at Dodge City, Kan. Mr. Davis enlisted in this city some three years ago. The Globe at Dodge City, says: Any scrap of information about the war prospects with Villa is mighty interesting just now to J. E. Davis, of Dodge City, just a month out of the regular army in which service he spent three years guarding the Mexican border. Davis thought there would be a rumpus when he enlisted three years ago at La Grande, Oregon, but he watched the Mexicans perform for three years and decided there would be no war. He is watching to see if trouble starts and if it does he says he will enlist again for three years to get a crack at Villa.

Davis served in the Twenty-second infantry and was stationed at Douglas and Naco, Arizona. There were 5,000 soldiers at Douglas and Davis says it was no unusual thing for the whole bunch to be in line with rifles loaded and machine guns planted. Every time the Mexican "army" across the line received news of a Carranza victory they would begin to sound their "hooley gooleys", as the soldiers call their trumpets, and the whole bunch would march up and down the fence that marks the line between the United States and Mexico. Fifty feet back of the fence the Mexicans would be parading, cheering and jeering. Ten paces north of the fence the United States regulars would be lined up, scowling and silent. The Mexicans went as far as they dared to torment the soldiers, even throwing stones across the lines sometimes, but the officers kept the United States soldiers from retaliating in any way.

One night the Mexicans amused themselves by following with a searchlight a big negro trooper as he paced back and forth at guard duty. He became tired of the attention and with his big Springfield sent a bullet through the light a mile and a half away. The Mexicans rigged up their smashed light and turned it on him again. And again the trooper sent a bullet through it. That was enough for the Mexicans but it brought the trooper's captain out on the run for the officers had strict orders to prevent anything that might cause international complications. But the trooper was thoroughly mad. He covered his officer with his revolver and backed across the line into Mexico. Ultimately he joined the Carranza troops and a few weeks later when the troop trains of the head of the Mexican government were allowed in the United States to transport troops to another point to repel a Villa raid the deserter was caught. His penalty was a twenty-five year prison sentence for desertion.

Davis says the Mexicans who do the fighting are usually the Yaqui Indians or mixed breeds, ignorant and vicious. But he believes that if this government invades Mexico it will mean an uprising of all classes to repel them.
