have afforded splendid opportunities for placing of bets, and many-angled stakes have been posted, though all were more or less of small denominations. Interest in betting kept up during the day.

Voting Began Early

In all parts of the county voting began earlier than usual. In La Grande, especially, voters are wanted to hold off until the last hour or two and interfere with the workmen's opportunities to vote. Today it was different and the polling places were visited early.

Women Out Early

Women too, got out early though the greater numbers came out in the afternoon. But in a large number of instances, housewives came out before the noon hour. Due to the occasion of a prominent social function, many didn't come out to vote until they were decked out in their party gowns—despite the cloudy, cold uncomfortable weather.

Confusion on North Side

Due to an error in the official notice of polling places Precinct No. 5 was not definitely located until well along in the forenoon by the general masses. Some hunted for the Davis home in vain. It is located near Pine and V avenue. The "Kammerer residence" referred to in the official notice as being located on Washington, is better known as the Wines apartment or Washington apartment, though it is owned by Mr. Kammerer.

JUDGE KNOWLES HOME.

Term in Wallowa County Ended for Primary Recess.

May term cases in Wallowa county were terminated in time to let those attending court get home to vote. Judge Knowles, presiding judge, returned last evening from Enterprise and will remain here until the June term opens in this county June 4th.

The May term came to a close yesterday morning, following a verdict in the George Tucker case.

The verdict in the Tucker case was "not guilty." The trial had been hard fought, and had attracted much interest. Mr. Tucker was accused of an attack with intent to kill. The trouble arose at a dance at Meek's hall on the Upper Prairie creek in the winter, and the testimony at the trial was conflicting and varied. Of the case the Enterprise Record Chief says:

Mr. Tucker came into the hall immediately after there had been a fight outside, and it seems some thought he had had a part in it. Shortly afterward he was seen with a revolver in his hand, holding it in the air above his head. Testimony as to where the weapon came from and how it was being handled was conflicting. It was discharged during the confusion, the bullet going through the ceiling.

In a general way, there were two sets of witnesses; one side representing that Mr. Tucker was the aggressor and had pointed the weapon at Fred Doty; the other side saying Mr. Tucker was trying to keep out of trouble which had been started by others.

The judge's instructions permitted one of three verdicts, according as the jury construed the testimony. One verdict possible was guilty as charged; another, guilty of assault, without intent to kill, and the third, not guilty.

The prosecution was conducted by District Attorney O. M. Corkins and Mr. Tucker was represented by Daniel Boyd, A. W. Schupp and George E. Rummens of Seattle. The last named formerly lived at Pomeroy and Astoria and took part in some of the trials of years gone by in the county.

Shortly after the dance two men were arrested and pleaded guilty to taking whiskey to the dance, in violation of the new Oregon prohibition law. Yesterday's trial was entirely another matter, although growing out of the same dance.

Needs Are Less Than Expected.

Washington, D. C., May 19.—Secretary McAdoo has submitted to Chairman Kitchin of the house ways and means committee and Chairman Simmons of the senate finance committee revised estimates of government receipts and expenditures for the remainder of the current fiscal year and the next fiscal year, tending to show much less revenue is needed than was supposed.

Only \$150,000,000 additional revenue is needed during the coming year, 75 millions less than anticipated. All additional revenue will come from income, inheritance and munitions taxes. McAdoo's figures show the general fund balance will probably be \$150,000,000 at the end of the current fiscal year, and \$15,500,000 at the end of the next fiscal year. BABIES' CHANCES BETTER

Census Shows Healthiest Period Is Between 11 and 12 Years

Washington, May 16.—A native white New York boy baby now has at birth one chance in two of living to the age of 60. So it has been discovered by S. L. Rogers, Director of the Census, from an analysis of the vital statistics of the New England, North-western and Middle States.

At the end of his first year the New York baby has a trifle better than an even chance of reaching 64. He has one chance in two of attaining 70 under the same circumstances.

A native New York girl, at birth, has an even chance of living a few months past 64. At 22 her chance of reaching 70 is an even one.

Thus a native white man New Yorker at 42 and a native woman New Yorker at 22 have about the same chances of celebrating their 70th birthdays.

On his first birthday the chance that the boy or girl New Yorker will die within the coming year is only about one-fourth as great as it was at birth. The rate continues to decrease until the 20th year.

The healthiest time in the life of the average native New Yorker is between his or her 11th and 12th birthday. When the man grows to be 48 his chance of living is just what it was in his third year. When he is 62 his chance is as it was on his second birthday.

In its first year of life the boy New Yorker's chance of reaching his second birthday is nearly one-fifth less than if he lived in the country part of that state. Thus, at birth, the country boy in the Empire State has an expectation of 7.7 years more of life than the boy in New York City, until he is 39. The country man has more than five years' better chance of life than his metropolitan cousin. Not until the New Yorker is 88 is his chance of living longer better in the city than in the country.

Rutherford, of Eugene; County School Superintendent F. E. Fagan, of Sherman county, and David North, principal of Alsea schools. Many school boards over the state are making arrangements to send their teachers to the summer session of the normal school in June and July. She is a sister of the Misses Francesca de K. and Rosamond de K. Gilder and of Mrs. George de Kay Gilder. The late Miss Jeanette Gilder, authoress, was her aunt.
