University of Oregon, Eugene, May

Turner and Simpson Case Dropped.

Salem, Or., May 30.—Judge Percy
R. Kelly, of the Circuit court here,
yesterday dismissed the indictments
pending against Rex Turner, Salem
attorney, and Cleve Simpson, Uni-
versity of Oregon student, who were
charged with the larceny of state
money while employed as ticket sell-
ers at the 1915 State fair. The dis-
missal was upon motion of attorneys
for the state, who said that inasmuch
as the jury had disagreed at the trial
of Turner in April after the state's
best evidence had been submitted, the
probability of procuring conviction
was very remote. It was also stated
that the state's most important wit-
ness had removed from the state and
that the expense of bringing them to
Salem for another trial would be un-
warranted.
