Fifty Crack Swimmers in Annual Event

Chicago, July 29.—Fifty of the country's crack amateur swimmers were all set today for the Illinois Athletic club's ninth annual river swim, in the Chicago river this afternoon. The race is two and a half miles, starting at the mouth of the river in Lake Michigan and ending at the Fifth avenue bridge. The last

race was swum in 1915, the event being called off last year because of the Eastland disaster, when 812 excursionists perished in the Chicago river when the boat turned turtle.

TO PURIFY THE WATER

Action of the Mayor and City Council Will be Appreciated

Mayor Smith informs the Republican that steps will be taken immediately toward cleaning the city reservoir, analyzing the city water and patrolling Catherine creek for any conditions that tend to pollute the stream and the action is timely and will be appreciated by the people of the city.

At this season of the year there is danger of the water becoming contaminated in the source of the city supply, and it is meet and proper that steps be taken toward guarding the health of the city in this respect.

The pollution of Catherine creek by residents along the stream or by others should be met with prompt action on the part of the city authorities. There is a law against the pollution of the public streams of the state and the city authorities will see to it that such laws are enforced where the evidence is conclusive.—Union Republican.

Livery Barn as Garage.

Commenting on the fact that La Grande's livery stables have been consolidated, the Record Chiefstain says:

The same situation is found in Enterprise. For years three livery stables were open and there was business for all. Then times got dull and they had their ups and downs until recently when S. L. Burnaugh closed one for good and has nearly torn it down. The other was closed for months until Fred D. Rinehart had need for it in an emergency, and so of late he has conducted both. For ordinary trade one barn is enough.

This is particularly striking here because so much produce is hauled here for shipment from points as far as 50 miles distant, and it has to come in wagons. Also, owing to the rough nature of the country and the sparseness of the population, many of the roads are passable for automobiles only part of the year. But farmers have been the largest buyers of cars this season, and they are using them more and more, leaving their horses home.
