Gibbons Ready to Defend World's Championship

New York, March 21—Mike Gibbons, long recognized as the foremost middle-weight in this country, and acknowledged by many to be the peer of any in the world, has declared himself champion of his class and says he will meet all challengers, the only stipulation being that they agree to weight in at 158 pounds, give or take two pounds.

"I will adhere to the old rules of the London prize ring," Mike announced, "meeting all comers, give or take two pounds from 158, the proper middleweight limit."

Mike has been having the time of his life trying to force Lee Darcy the Australian, into a match, with no success. He now is ready to pass up the famous Kangaroo jumper and let Darcy do the chasing.

It would be a fine thing for boxing if Mike were given the title. It would put an end to such exhibitions as that put on a short time ago in New York when Jack Dillion and Al McCoy battled. Also, it would end for all time and argument as to whether Al McCoy is entitled to the championship.

As a matter of fact, McCoy isn't entitled to the championship any more than any one else. To be a champion a boxer should be able to defeat the best in his class. McCoy hasn't even kept pace with Freddie Welsh.

There is only one real defeat chalked up against Mike since he began boxing in 1908 and that was when Jimmy Clabby was awarded a decision at the end of ten rounds with the famous St. Paul flash. He has shown badly in one or two no decision contests, among them being one with Soldier Bartfield and one with Paaky McFarland. He was generally credited with having been out boxed in both of these affairs.

If Gibbons sticks to his claim and intends to defend the crown he will have plenty of supporters. Most any one will be willing to concede him the title.

New Psychology of Work Makes Successes of Failures

In the April American Magazine an article by Herman Schneider, Dean of the School of Engineering of the University of Cincinnati, who has devoted his life to a study of human ability and fitting the right job to the right man. Among other things Dean Schneider says:

"There is a new psychology of work. One of its most inspiring principles is that the man who makes a failure on one job is likely to make a success of the job of an opposite type, assuming, of course, that he fails in the face of real efforts. This is the significance of failure: it points the way to an occupation which means success. Failure to a willing man is merely misplacement on his job. Failure at one job is not a calamity; it is an indication. Every failure is a guide-post to success.

"Fortunately some employers are beginning to understand this. When a man fails in one job, they shift him to another of an opposite type. And if the worker is not lazy or dishonest, he usually succeeds. No foreman should be allowed to discharge a man. He should merely report to a central officer that the man is not successful on his particular kind of work. In another department he may break records. To fire a man who has failed at one job is poor business. The shifting

FRED FULTON THINKS WILLARD IS NOT MUCH OF A CHAMPION

Ponderous Plasterer From Minnesota Says Willard Is Not Much of a Champion—Fulton Is Anxious For a Fight and Is Said to Have a Terrific Left Punch.

New York, March 23.—Fred Fulton, the ponderous plasterer from Minnesota, who has lived up to his trade with considerable vigor in New York performances, wants to know why in sam hill Jess Willard prefers the life of the sawdust ring to one with a canvas spread over the soft spots. Fulton figures that a few thousand dollars a minute or some such inducement of an allied nature should at least be sufficient to make Willard put a ten-day clause in his contract so he could fight once in a while instead of just showing the circus patrons what a guy he is. "Look here," he said, "There's a champion who isn't, not by no means. He goes around the country showing the curious multitude how he knocked Jack Johnson stiff, and then he disappears. He wears a lot of leather breeches and other things that remind the old-timers of the Rio Grande, and gets away with it. He don't show 'em how he knocked out anybody since he and Johnson pulled off their little Havana meeting. And the reason is there ain't no other." Fulton wants to fight. He's just aching for a chance to get to Willard. He's almost as tall as the big Kansan and he carries a terrific kick in his left tentacle. He's the right man to fight Willard and it does seem a little strange that Willard isn't willing. Of course Willard might dispose of Fulton in a round. If he did he would become a lot more popular than he now stands. If Willard lost, well, the public would just heave one long sigh and hope

that Fulton would be more of a champion than Willard had been. Big Jess would just simply gently slide into pugilistic oblivion, for everyone knows there wouldn't be a chance for him to whip another title holder. Looks like a chance for Jess to die the happy fistic death he has been waiting for, or make himself so solid with the public that he never will be dethroned in popular favor. It is the inherited duty of a heavyweight championship to defend his title whenever a good man appears. The popularity of many of the old time bruisers lay in the fact that they willingly vaulted the ropes of a ring and hammered some opponent for a dozen or so rounds. There is just one man who stands out now over the many contenders for Willard's crown and his name is Fred Fulton. He is the man who must eventually meet Willard. Let's have it.

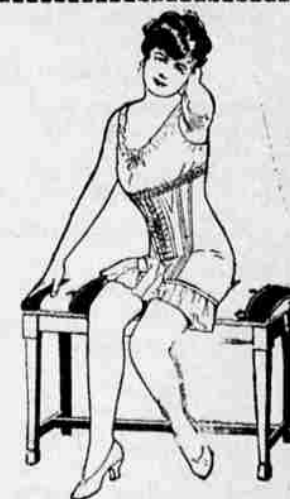
