LA GRANDE CITIZEN MOVED BY SCENES AT DEPARTURE OF BOYS

(Letter written by K. Dyal to his wife, after witnessing the departure of the Hospital Unit from La Grande.)

Dear Hermie:

The other night I witnessed once in my life a scene wherein even the calloused carelessness of my soul was aroused, and bathed in profound sympathy and regret. Young men held in their arms sweet-hearts, possibly and in all probability the last time, while the tears burning like a boiling cauldron trickled down their cheeks, and sorrow unmitigated danced with sympathy, her twin sister; upon their eye lashes, mothers in deep despair longingly and effectually clasped to their bosoms the child they had only a few years hence, in pain given birth too, and with this last embrace she could still feel the touch of the baby hand, the caress of

the infant love which only a mother knows, while her gray locks magnified themselves one hundred fold in the eyes of those who watched her boldly, restrain her feelings and whisper, "God Bless You." I was not called upon to part with any one of blood relation but I could see I know. Something felt, a feeling that can't find utterance to express itself. They withheld like heroines. They were, until possibly they entered the private chambers of their own domicile, and then no doubt many a pillow was moistened, or christened with tears as sacred as any water ever blessed or dedicated for any baptismal or sacramental service, by any priest or prophet.

Father there were, men who've battled and wrestled adversity and given to their sons the best of a free and unsullied opportunity to educate and develop themselves along some chosen professional line.

These fathers though better able to

conceal emotions, nevertheless, they like the natural parent of the sons of men felt a loss and grief which no one can dispell. These feelings of interest, hope, sorrow, longing and grief, were the result of the last scenes accompanying the departure of La Grand's 1st. Hospital Unit. The boys who will put our town on the map. The young men, who in their devotion to country, will demonstrate their heroism in hundreds of ways.

I estimate they are men of tried sinews, insured to hardships, every one a lion in his determination to see right prevail.

Their fathers and mothers are our best and foremost citizens "Like mother like son." Dead indeed, must be the soul of man, which could lie dormant and unmoved, at such a separation of fond hopes and glorious anticipations. My hopes like that of every man and woman, who loves the upright, the noble, will lead us to always pray that they who so willingly left us now, may return in peace, and bring with them the honors and glories which only men of their type can force. Such scenes as these makes every man appreciate more the mother of his son, I think more of you as result of the three you have with you.

RISK OF FIGHTING MEN NOT AS GREAT AS IMAGINED

Washington, August 27.—(Special)—That the risk of the fighting man is not nearly so great as is popularly imagined is the belief of Marine Corps officials here who have compiled statistics covering the Allied losses in the war.

A careful estimate shows that only one man in fifteen is killed, and one out of five hundred loses a limb. Recent reports from French and British hospitals show that about 95 per cent recover from wounds, while about 90 per cent are able to return to the firing line.

While the Marine Corps officials hold unbiased views in regard to the expected casualties among their own troops in France, it is pointed out that the "Soldiers of the Sea" recently engaged in warfare in Haiti suffered less than one per cent losses. These were sustained while covering a wide terrain, fighting from house to house, and capturing and holding small redoubts, taken one by one from the enemy. This method of warfare is said to be rapidly superseding the trench system on the western front.
