DR. J. E. ANDERSON ON AN INSPECTION TOUR

CANDIDATE FOR REPUBLICAN NOMINATION FOR GOVERNOR HERE

Father of the Dry Law and Member of the Legislature Will Come Back Later On a Speaking Tour.

A well-dressed, genial looking man clean shaven, with a bright, alert eye, walked into the Observer office this morning accompanied by Colon R. Eberhard.

He proved to be Dr. J. E. Anderson, candidate for the Republican nomination for Governor.

Dr. Anderson hails from The Dalles. He is the father of the present dry law in Oregon and has been an active and efficient member of the legislature.

Dr. Anderson is making no big boasts about his candidacy, but he is organizing it thoroughly and he expects to get nominated. Since he came out he has over eight hundred personal voluntary letters endorsing his candidacy, which is pretty good.

After a preliminary survey, Dr. Anderson expects to make a speaking campaign through the state and expects to include Union county on his itinerary.

Candidate for Governor.

Secretary of State Ben W. Olcott has announced his candidacy for governor. He announces that if nominated and elected he will resign as Secretary of State, thus permitting Governor Withycombe to appoint his successor. He will run on an economy and efficiency platform.

Mr. Olcott says:

"The state is similar to a large business corporation. It is the people's corporation. A private corporation, unless backed by unlimited resources like the state, would not long survive if it did not have at its head a man who fully devoted his time and capabilities in applying business judgment and business economy to its affairs. Neither can the state's business run of itself and keep within the bounds of economy and on a plane of efficiency. As governor I would expect to be the business head of the great corporation of the people and would apply my energies to make a success of the business.

Because all state business flows through the office of secretary of state no office affords such intimate knowledge of state affairs as does it. This office I have held for the last seven years. The knowledge and experience thus gained will be of immense value to a chief executive. Added to this is my familiarity with state institutions and activities gained as a member of the Board of Control.

"The people of Oregon have emphatically voiced their sentiment in favor of prohibition, and if I am elected governor I shall consider it my duty to use the power of that office to see that the laws are enforced. And if, while I am governor, the 'dry' amendment to the federal constitution, providing for national prohibition, is submitted to the states for ratification I shall give it my endorsement and urge its speedy approval by the Oregon legislature. Likewise, should the national woman's suffrage amendment pass Congress, as it now appears it will, I shall give it similar endorsement.

"As the proper performance of my duties as secretary of state requires my undivided personal attention, I shall spend no time campaigning over the state. The people of the state are paying me a salary to look after their business, and I cannot properly do this when away from the office."

R. N. Stanfield is in Portland and will start this week on a tour of the Willamette Valley.

L. J. Simpson, of North Bend, will soon announce his decision as to whether he will run for the Republican nomination for Governor.

Northcliffe Praises Stettinius.

LONDON, Jan. 28.—Viscount Northcliffe, in the course of an interview yesterday said that the appointment of Edward R. Stettinius in charge of war purchases for the American Army was a piece of world news of the highest importance.

"In my considered opinion," said Lord Northcliffe, "he is easily the ablest business organizer in the ranks of the allies or the enemy."

Labor Disturbances In Rhenish District

LONDON, Jan. 28.—Severe disturbances in the Rhenish industrial district have occurred, according to Netherlands advices.

It is reported machine guns were distributed to troops in Mulheim. The enemy raided the British advance post northeast of Langenarck, and three Britishers are missing.

Hostile artillery occurred southwest of Cambrai and north of the Lens-Paschendale sector.

Hostile reconnoiterers around Leverguier were dispersed.

EX-CONVICT ATTEMPTS TO KILL WIFE AND HIMSELF

CHEHALIS, Wash., Jan. 28. (Special.)—Myron L. Taft, an ex-convict from the Oregon penitentiary, yesterday made a murderous attack on his wife, Mrs. Lois Taft, at their Folsom-street home in Chehalis, beating the woman over the head with a hammer until he thought her dead, following which he rushed into the house and cut his throat with a razor.

When neighbors who had rushed to the rescue of the shrieking woman broke through the bolted door, Taft was dead, with a gaping wound across his throat. At the St. Helens hospital, where she was hurried following the assault, it was reported last night that Mrs. Taft would recover.

The affair happened in broad daylight, and before Taft had got back into the house, a number of neighbors who heard the woman's screams were hurrying to the scene.
