NEW FOOD ADMINISTRATION RULES NOW IN EFFECT

APPLY TO SALES BY WHOLESALE DEALERS AND RETAILERS

Wheat Flour Must Be Sold At Reasonable Advance Over Purchase Price—One Pound Substitute to Go With Every Three Pounds of Wheat Flour.

T. J. Scroggin, representing the Food Administration in Union county, has received the following rules from Federal Food Administrator Ayer.

In accordance with the President's proclamation of this date and the rules and regulations promulgated by the Food Administration, the following rules become fully effective on Monday, January 28, 1918:

Wheat flour and the substitutes listed below must be sold at not more than a reasonable advance over actual purchase price of particular goods sold, without regard to market or replacement value and in no case at a greater profit than obtained before this order became effective.

their sales to the retail trade on this basis. Due to congested traffic conditions and the consequent unequal distribution of some of the substitutes I have secured a modification of the 50-50 order for this State.

The rules issued January 17, 1918, covering the quantity of flour to be sold to each customer, remain in full force and effect. FLOUR—No dealer is permitted to have on hand more than a 30 day's supply; no dealer can sell to city or town consumers more than one-fourth of a barrel at one time and no consumer should have on hand more than this quantity.

WOMAN IS JUDGE IN DIVORCE CASE

DAUGHTER IS EMPOWERED BY KNOWLES TO GIVE DECREE ON HER PARENTS

ENTERPRISE, Jan. 29.—(Special.)—The Enterprise Record-Chief-tain says:

For a time, Mrs. Samuel Scott was judge of the Circuit court the first of this week. Judge J. W. Knowles turned over to her the divorce suit between her parents, Jacob I. and Nettie Crawford, of Imnaha, and the decree and order were entered in accord with her findings.

Anxious to have the case disposed of according to its merits and to the best interests of all concerned, Judge Knowles concluded that Mrs. Scott, oldest daughter of the couple, was the one person qualified to decide. He told her the order would be made precisely as she directed.

Mrs. Scott concluded that a divorce should be entered and that two of the children, Jesse and Emory, should be given to the father, and two others, Ruth and Reba, should remain with their mother. And so the order was entered.

Judge Knowles concluded the adjourned term of court on Tuesday and went to La Grande that afternoon, accompanied by Reporter H. R. Hanna.

In the hard fought suit of A. M. Rinnells vs. W. E. Leffel et al, involving the disposition of a large cash commission arising from a sale of real estate, the court heard exhaustive arguments. A. S. Cooley is counsel for Mr. Rinnells and A. W. Schaupp and Colon R. Eberhard of La Grande represent the defendants.

The court took the matter under advisement and will give a decision in vacation.

An injunction was issued, on petition of Henry W. Weatherspoon, restraining Peter Cote from using certain premises between the upper Sheep creeks as a sawmill site, and from cutting any of the plaintiff's timber there. The complaint alleged that Mr. Cote had no rights on the premises but had set up a mill there and cut considerable timber.

Other proceedings of the court follow: C. R. Fones vs. C. Murdock; plaintiff's action dismissed; judgment against plaintiff for costs.

Mary Thompson vs. B. H. Teat et al; decree for plaintiff. Nannie Fields vs. F. D. Rinehart; verdict for plaintiff, under replevin.

Principals in Court Case. ELGIN, Jan. 29.—(Special.)—Mr. and Mrs. C. C. Henry and J. W. Bickford, all well known local residents, were the principals in a sensational case in the Justice court.

Bickford preferred charges against C. C. Henry for an attempt to extort money. The complaint was filed in the Justice of the Peace Court and the preliminary was held with District Attorney Hodgkin appearing for the State and Attorney L. Denham for the defendant.

The complaint alleges that "on the 3rd day of January, in the County of Union, State of Oregon, then and there being, did then and there unlawfully and feloniously verbally threaten to do injury to the person of the said J. W. Bickford with the intent and there to extort a pecuniary advantage and property from the said Bickford and with the intent to compel the said J. W. Bickford to do an act against his will, by then and there pointing a revolver at the said J. W. Bickford and threatening to kill him unless he paid the defendant the sum of \$5,000.00 and to further draw an order in the sum of \$225.00 on the East Oregon Lumber Company in favor of defendant." The preliminary resulted in Henry being held and his bond placed at \$500, which was furnished.
