LOUWAGERS

Cattlemen and Sheepmen Decide to Buy the Hatchet in Montana

HELENA, April 25.—Without special fanfare, one of the longest and most enduring wars in the annals of the west has closed. When a few days ago, the wool growers of Montana in convention at Miles City, voted to join in a body, the stockmen's association, also meeting in that city, the hatchet was buried between two industries whose interests have been considered diametrically opposed for decades and whose differences on not a few occasions, have flamed forth into miniature civil war.

It was the range the sheepman and the cattlemen fought over and the range is almost gone. Henceforth, cattle and sheep will be largely raised in enclosures and there is no longer real animus between the two pioneer lines of endeavor. It is declared.

The first sign of the truce came in the last Montana legislative session when sheepmen and cattlemen, for the first time, worked side by side for agricultural legislation.
