

GERMANY IS TOLD ON WHAT TERMS PEACE MAY BE HAD

WILSON CALLS FOR A SESSION

SPECIAL MEETING OF CONGRESS ON MAY 19.

President Not Expected to Be Present at Opening Day, Which Is Earlier Than Anticipated.

(By Associated Press to The Observer)

WASHINGTON, May 7.—President Wilson has issued a call by cable for a special session of congress to meet May 19. White house officials said the President was guided in naming an early date by Secretary Glass, due to the necessity of passing the annual appropriation measures which failed in the closing days of the last session. The President is not expected to be here on the opening day. The date is much earlier than democrat leaders had expected.

EXPERTS WORK ON BOMBS

Bureau of Mines Finds May Day Explosive of U. S. Manufacture

WASHINGTON, May 6.—Experts of the bureau of mines analyzing the bombs used in the attempted May day outrages proceeded far enough to convince them that the gelatin dynamite used was of American manufacture. It is expected that the firm producing the explosive can be identified from the chemical formula and the perpetrators perhaps traced in that way.

CHINA MAY NOT SIGN TREATY

PEKING, May 7.—The Chinese cabinet has decided to instruct the Chinese delegates not to sign the peace treaty, assigning German rights in Shantung to the Japanese.

Cautioned By Japan.

TOKIO, May 7.—Japan has notified China that the anti-Japanese agitation in Peking is liable to cause misunderstandings and that it would be well to prohibit the "national disgrace" meeting planned today in Peking.

IMBLER BANKER WILL ENGAGE IN BUSINESS HERE

T. K. Bellamy, formerly with the State Bank of Imbler, has removed with his family to La Grande and will open an insurance office here as soon as rooms can be secured. Mr. Bellamy represents the Oregon Fire Relief Association, of McMinnville, the company that subscribed \$51,000 to the Victory Loan.

HOOP TRAIN HERE FOR HOUR

The troop train carrying 400 soldiers of 316th Sanitary train is due to arrive in La Grande at 5:15 this afternoon and it is understood that it will remain here for one hour. This will be one of the largest returning bodies of men of the 316th supply train and many La Granderes may find friends among them. This unit is part of the 91st division and with it are 68 men of the 316th supply train. As the men are expected to be here at the dinner hour Red Cross and Salvation Army workers are making preparations to feed a great many of them.

Army Must Be Reduced to 100,000—Forts East of Rhein to Be Razed—Occupation of Germany Reduced in Proportion to Reparation Made—Assent to Trial of ex-Kaiser—Any Violation of Conditions An Act of War—Recognition of League of Nations, But Without Membership—Delegates Say They Will Sign, But That Germany Will Not Pay.

VERSAILLES, May 7.—(By Associated Press.)—Germany was told this afternoon the terms on which the allied and associated powers will make peace with her. Delegates of the Twenty-seven nations which are parties to the pact attended the memorable assemblage.

Say Germany Will Not Pay Indemnity.

PARIS, May 7.—German delegates to the peace conference declare that they will sign the peace treaty, but that Germany will not pay an indemnity.

League Covenant Presented.

PARIS, May 7.—The league of nations covenant is the first section of the peace treaty, which is the longest ever drawn, being about eighty thousand words. It is divided into fifteen sections. It does not deal with the questions affecting Austria, Bulgaria and Turkey, except insofar as it is binding upon Germany to accept any agreement reached with her former allies.

Germany, by the terms of the treaty restores Alsace-Lorraine to France; accepts internationalization of the Saar Basin, temporarily, and of Danzig permanent. It agrees to territorial changes toward Belgium, Denmark and East Prussia; it cedes most of Upper Silesia to Poland, and renounces all territorial and political rights outside of Europe, especially to Morocco, Egypt, Siam, Liberia and Shantung; also recognizes the total independence of German-Austria, of Czechoslovakia and Poland.

Military Restrictions.

Germany's army is to be reduced to 100,000, including officers. Conscription within her territories is abolished, all forts fifty kilometers east of the Rhine are to be razed; all importation, exportation and nearly all production of war material is to be stopped.

Allied occupation of parts of Germany is to continue until reparation is made, but will be reduced as Germany fulfills her obligations. Any violation by Germany of the conditions as to the zones east of the Rhine will be regarded as an act of war.

Reduction of Navy.

The German navy is to be reduced to six battleships, six cruisers and twelve torpedo boats, but without submarines. The personnel is not to be over 15,000. Germany is forbidden to build forts controlling the Baltic and must demolish Heligoland, open the Kiel canal to all nations, and surrender fourteen submarine cables. No air forces are permitted except unarmed seaplanes to detect mines.

Must Make Reparation.

Germany must accept full responsibility for all damages caused to the Allied and associated governments and nations, and agrees specifically to reimburse all civilian damages. It is to pay the shipping damage on a ton-for-ton basis by cessation of a large part of her merchant, coasting and river fleets and by new construction, and is to devote her economic resources to the rebuilding of the devastated regions.

Accept League Without Membership.

Germany is to agree to return to pre-war tariffs without discrimination, to allow freedom of transit through her territories; also to agree to the trial of the ex-Kaiser for a supreme offense against international morality. A league of nations is accepted by the allied and associated powers as operative and by Germany in principle but without membership.

Summary to Be Published.

NEW YORK, May 7.—An 11-000-word summary of the peace treaty is to be published today.

FIUME UNDER A MANDATORY

PARIS, May 7.—As a basis for re-summing negotiations in the peace negotiations, Premier Orlando accepted the proposal that Italy administer Fiume as a mandatory of the league of nations until 1923, after which time it is to revert to Italian sovereignty.

OFFICER KILLED BY A BANDIT

CHIEF OF POLICE RALPH GIBBON, OF THE DALLES, IS SHOT BY FUGITIVE.

WASHOUGAL BANK ROBBER IS SUPPOSED ASSAILANT

Had Arrested Two Men, When One Fired the Shot and Both Made Escape—One Was Recaptured and a Posse Is in Pursuit of the Other—Lynching Was Threatened.

THE DALLES, Or., May 7.—Chief of Police Ralph Gibbon, of The Dalles, was fatally shot this morning when he arrested two men, thought to be the Lewis Brothers, wanted for the robbery of the Washougal bank. Both escaped but one was recaptured. A hastily organized posse is in pursuit of the other.

Lynching Was Threatened.

A crowd of citizens tried to take the bandit away from Sheriff Christian when he was recaptured, but the sheriff held them off at the point of a gun and put the prisoner in jail. The other robber escaped across the river into Washington.

When Chief of Police Gibbon arrested the men he had not searched them when one of them pulled a gun and shot him on the street, while on the way to jail. The chief of police died two hours after he was shot.

Third Bandit Also Escapes.

VANCOUVER, Wash., May 7.—Twenty-five hundred dollars of the Washougal bank money was recovered last night when the bandit, known as Primrose, was arrested. He later escaped, after wounding one of the posse in the hand. He is still at large.

MEMBERS OF OREGON SUPREME COURT PAY VISIT TO LA GRANDE AND BAKER

Union County Bar Association Entertains the Justices at Luncheon—Splendid Time Enjoyed By Everyone Present—Visits May Be Made a Part of the Court's Program in the Future.

Reaching La Grande this morning on a Get-acquainted-with-the-state trip members of the Supreme court of Oregon have enjoyed the day as guests of the Union County Bar Association in a very pleasant manner. It has been a delightful day for La Grande people for many have had the pleasure of meeting the different court members and learning from them that the supreme court is not all intellect and dignity. They proved to be the finest kind of "folks."

At the noon hour the Bar Association dined the Justices at the Foley hotel and a few citizens of the county outside the association were invited. Judge J. W. Knowles acted as toastmaster and his knowledge of each member served him well for he kept a vein of humor running throughout his introductory speeches. The first speaker called upon was Oregon's grand old man, Chief Justice Thomas McBride. Besides his remarkable wisdom Judge McBride is a "regular" fellow in every respect, and the remarks he made at the dinner pleased everyone. Years ago, just about 1863, Judge McBride mined in the Auburn mines of Baker county, and today he admitted that the remuneration for that work was considerable more in proportion than he is receiving today. But at that, the Judge is happy and loves his work.

Justice Dean of Umatilla county made a talk on how an Eastern Oregon man got on the Supreme bench and in a very interesting manner told of his experiences. He said that a judge of the Supreme court is like a base ball player, if he can't make a strike they put him on the bench, which brought forth generous applause.

Justice Lawrence T. Harris, of Eugene, who is the youngest member of the court, talked in a very pleasing manner about the work of the state, and asked that La Grande make an opportunity so that the members could play a return date here in the future.

DECISION TO HAVE A BIG TIME THIS YEAR

Judd Geer and John Dean, Fruit Men, Here Interviewing the County Court

The city of Cove will have its annual cherry fair this year. This has been determined once and for all by the people of that section of the valley and today Judd Geer and John F. Dean, two of the leading citizens and fruit growers, are here interviewing the county court on the possibility of county co-operation for the exposition.

Last year Cove laid off because of the war. She was also hit by a freeze which took a good deal of the blossoms off the trees. There was a lurking suspicion that the Kaiser at that time was controlling the weather and visiting this punishment on Cove because of her patriotic work during the war, but this year it is different, and while there has been some frost it is estimated there will be at least fifty cartloads of cherries shipped from Cove during the season. With such a crop the Cherry show is a certainty.

RED GUARDS KILL ROTERS

Four Hundred Moscow Citizens Reported Shot by Bolsheviks

LONDON, May 7.—Four hundred persons were killed in Moscow last week when the Red guard was called upon to disperse rioters, says an Exchange Telegraph dispatch quoting advices from East Germany. The casualties resulted when crowds assembled demanding food and shouting "Down with Lenin and Trotzky."

START CAMPAIGN FOR GOOD ROADS

AD CLUB DELEGATION VISITED IMBLER LAST NIGHT

Program for County Outlined and Support of Two New Measures by All Voters Was Urged

Some twenty-five local business men comprised the good roads delegation which went to Imbler last night as representatives of the Union county Ad Club to talk to the tax payers of the Imbler district on matters concerning the good roads program which has been outlined for Union county. Imbler's representatives at the meeting were few but they were very representative and assurance is felt that considerable good for the cause resulted from the meeting. The meeting was held around the dinner tables which had been fairly loaded with a good, old-time country supper. It was no longer loaded when the diners got through, but it put everybody in fine spirit and contributed that bond of congeniality so necessary for the success of meetings where people have to be talked to about opening their pocketbooks.

The Proposition Explained

Sam Brooks, of Imbler was chairman, and after the dinner was over started G. L. Larison off on his favorite pastime—boosting for county-wide hard surface roads. Mr. Larison displayed map of the county, showing the roads that have been planned, together with all facts regarding cost per mile, resulting increase of taxes, and the time necessary to retire the bond issue which must be put over to build the roads. To put a paved road into every town in the county from the state highway will cost about \$2,700,000; the resultant increase will be five mills on the dollar; and in twenty years the whole indebtedness, with interest, will be paid off, said Mr. Larison. He then explained the two new measures which will be voted upon at the elections June 3rd—the six per cent. county indebtedness bill and the one mill market roads bill; this latter being the measure introduced by Senator Walter M. Pierce.

No Bond Issue June 3rd

The value of these visits which have been arranged to the various towns was proved last night by the requests of the Imbler men and of the delegation which had come up from Elgin for information regarding these two measurements and as to what they would vote on at the election next month. It seemed to be a general idea that there was to be a bond issue submitted June 3rd, but it was explained that this was not the case. As the speakers explained, there could be no bond issue voted for more than a two per cent. indebtedness under the present state law, and as a two per cent issue would not begin to cover the
