

GOVERNOR HART NOT FOR STRIKE

WASHINGTON, Oct. 30. (AP)—Gov. Hart is not in accord with mine workers in their demand for a strike.

Gov. Louis F. Hart last night formally notified Robert Taylor, president, Ernest B. Taylor, secretary, and the industrial members of district No. 10 of the United Mine Workers of America, that he would not tolerate any attempt to force the government into submission.

"It is a right inherent in all citizens to demand that the government be kept out of business," he said. "It is necessary to preserve the peace and order of the state."

Gov. Hart's message was wired to the headquarters of the miners at Seattle. The telegram reads: "For several weeks the miners have been demanding a strike to the effect that all the coal mines in the United States would be closed November 1. So far as I can ascertain the coal miners of the state are in no way organized to do this. It is the duty of the state to protect the public interest and to prevent suffering."

"I have no desire to participate in the attitude of the federal administration. However, it is the duty of the state to protect the public interest and to prevent suffering. It is unnecessary to argue how the state can protect itself and its citizens. Sufficient to say that it is the duty of the state to do this."

As citizens who believe in constitutional government, as men who have regard for your fellowmen, and more for women and helpless children, I ask you to calmly and soberly consider the situation. It is upon the people of this state that the burden of the responsibility for a government of the people, by the people, for the people, rests. It is upon the people that the burden of the responsibility for suffering humanity rests.

BANK ROBBERS MAKE WRITTEN CONFESSION

Bill Underwood, and James Miller were arraigned before Judge James B. Tucker this morning on a charge of robbing the Mendocino bank at Springville, October 8, and taking therefrom \$15,100. All waived preliminary hearing and were bound over to the district court. All three men have given sheriff J. T. Williams a written confession of their guilt, which confessions give in detail an account of their lives from the time they left Omaha, Nebraska, more than three weeks ago until they were arrested.

There were four men involved in the robbery, the other man being Charles Wilson who left the party after the robbery at Salt Lake City, taking with him his share of the spoils amounting to from \$3500 to \$4,000. In her confession, which was the first given to the sheriff, Mrs. McCarthy states that she is 28 years of age and the time they left Omaha, Nebraska, she tells of the party came to meet to take a trip from Omaha to Spokane, Washington, where she says she has relatives. When they arrived in Provo they stopped on the outskirts of the town near the Provo river where she and Miss Devers were left, while the men went away. The women did not know where the men were going when they left to commit the robbery according to Mrs. McCarthy's confession. Devers and Grace Devers, the younger woman of the two, was only 19 years of age, are brother and sister. From the confession of all parties now in custody it appears that Wilson, who made his escape, was the principal character in the robbery; he having entered the bank first and gave the command to the cashier and later locked him in the vault. After having committed the robbery, the men drove back to Provo and picked the women up and drove into Salt Lake county. After passing the point of the mountain they camped for all night. While the women were preparing the meal the men went out into the willows a short distance away and counted the money and divided it, \$15,000 in all. They then drove into Salt Lake city, where Wilson left them. The others continued to Ogden where they spent the night and then continued their journey north at Snowville, Utah, a small settlement for 10 miles south of the Idaho line, they had trouble with their automobile and were informed by the garage men that it would take three days to repair the car. They spent the night at Snowville and the next day they took a taxi and were driven to Malad, Idaho, leaving their car at Snowville. While at Malad the party separated; Frank Smith and Grace Devers headed for Ogden, but stopped at Brigham city, where they were arrested. The other three took a taxi for Pocatello, Idaho, where they boarded a train for Spokane, but were taken off at La Grande, Oregon and placed in jail awaiting the arrival of Sheriff Williams who went there to get them. While in jail at La Grande, the men confessed to having burned the liberty bonds in their possession which they had concealed in their socks.

It is the belief of Sheriff Williams that the women are respectable, and were innocent of having committed any crime or having been accomplices to the crime. Mrs. McCarthy, according to her confession, about \$900.00 of her own money, which she received from her husband about three years ago. It is not thought that any charge will be made against the women.
