CAMPBELL HAS A TAXATION PLAN

Enterprise Candidate for Representative is Giving Study to Revised Tax Methods.

Believing that those who pay the taxes to support the state, county, city and school district should have relief from the heavy load on property, I am giving study to a plan of taxation that will, if ever adopted, distribute the burden in such a manner that the real estate will not be carrying approximately eighty per cent of the taxation as is the case now in Oregon.

This statement was made to the Observer by "Jack" Campbell of Enterprise, who seeks the Republican nomination for joint representative for Union and Wallawa counties on May 16th.

Mr. Campbell has been a resident of the district for some time, is a man who gives much time to the study of economic questions. He formerly lived in Kansas City.

LAST LINK IN ROAD ORDERED

Wallowa County Is Happy Over Decision of the Highway Commission Announced Last Evening.

(Special to The Observer) ENTERPRISE, Ore., May 13.—There is considerable joy throughout Wallowa county over the announcement of the Highway Commission yesterday to the effect that contracts for rock for the Wallowa hill road now being graded and the construction of the last link in the road between Lostine and Enterprise will be let at the June meeting.

This will complete the highway and will give Wallowa county an all-year road to travel from Joseph to Union county eliminating the Wallowa hill which has impeded the progress of this county.

LAMBING SEASON IN FULL SWING

Crop About 20 Per Cent Below Normal, Says Mac Hoke of Pendleton.

PENDLETON, May 12.—Lambing in Eastern Oregon is almost completed, according to Mac Hoke, secretary of the Oregon Wool Growers' association. The lambing crop was 20 per cent below normal, he said, a fact which he attributed to the extremely long feeding period of the winter and the general poor condition of the ewes. A large number of the lambs were lost because of the slow season, Hoke remarking that almost every lamb lost its halo of fat, adding that shrunken lambs never top the market.

Shearing this year was 15 days late because of the slugs attendant upon driving newly shorn animals out into inclement weather.

Practically all the shearing is now done by machine, the shearer's receiving 10 cents per head and board.

Sales of sheep have not been up to the winter market for wool and lambs, Hoke said. Two or three bands of yearling ewes have been sold to local sheepmen at \$8 per head. Demand is good, he said, but the financial condition of the sheepmen held back the price, which under ordinary circumstances would have run along with that for wool and lambs.

Contracts for lamb deliveries in July and August are offered at 9 cents.

Hoke estimated the total Eastern Oregon wool clip at 2,000,000 pounds, the average weight of fleeces being nine pounds for fine wool ewes and seven pounds for coarse wool ewes. The largest clip was the 250,000 clip of Fred W. Falconer, who has sheep interests in Ematilla, Malheur and Wallowa counties. The Falconer clip went to a Boston firm.

Sheepmen were prompt to respond to offers of from 30 to 35 cents a pound for wool, Hoke said. The financial condition of the sheepmen had much to do with the acceptance of the price, he said.

O. W. R. and N. Must Aid Hay Shippers

SALEM, May 12.—The state public service commission Saturday issued an order requiring the Oregon-Washington Rail Road & Navigation company to provide better loading track facilities at Hinkle station, Umatilla county for the benefit of hay shippers. The order follows a hearing on complaint of Lee Savely, Ralph Richards, Pete Sheridan, Elmer Gamble, J. M. Eick, and Thomas Richards, George I. Wampler, H. V. Moore, Allen Thompson and Charles Bartholomew, requesting the hay and wheat growers on "inter-ore" in Umatilla county.

speakable outrages committed under the veil of darkness.

Not Wanted Here. Oregon needs no masked night-riders, no invisible empires to control her affairs. Our courts of law, our law enforcing officers, our whole machinery of government are founded on the fundamental of true American citizenship and are second to no other state.

Star chamber proceedings, dark conspiracies, behind closed doors, are all foreign to best governmental principles. Danger lurks when masked men parade the streets on missions of a character known to some but themselves. Officers of the law can have no knowledge of the identity, character or aims of individuals who conceal their features, whose oath of allegiance to some private organization holds sway in their minds and whose motives are uncertain and unknown. Even the sanctity of our various churches is not proof against their invasion in disguise.

Appeals to Officers. "By virtue of the authority in me vested by the constitution of the State of Oregon to see that the laws are faithfully executed and enforced, I hereby call upon all law enforcing officers of the courts, sheriffs of the counties and any other law enforcing officer whatsoever to guard carefully against any infractions of the law, to assist that unlawfully disguised men be kept from the streets and to prevent further outrages and maraudings such as have occurred in some of our communities and in the state of California.

"I particularly cite section 2040 Oregon Laws, as a statute to be strictly enforced. The time has come to determine whether our state government shall maintain its orderly way, controlled by the voice of all the people, or whether it shall be turned over to some secret clique or club, to be made the tool of invisible forces working in the dark toward aims unknown to others than themselves. The true spirit of Americanism resents bigotry, abhors secret machinations and terrorism and demands that those who speak for and in her cause speak openly with their faces to the sun.

"I call upon all loyal citizens of this state to give support to the proper law enforcing arms of the government in this movement against masked riders or cloaked and disguised figures who unlawfully sulk about on secret missions for unknown ends.

Homes Threatened. "If masked men are permitted to roam promiscuously at large it will not be long before our wives and daughters will know no safety, our homes will no longer be our castles and the streets will be scenes of disgraceful riots. These practices must cease if there is law in our land and true Americanism is to prevail."
