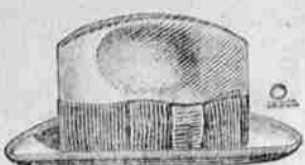

DEPENDANT WINS. ROBERTS, Ore., Jan. 25.—The case of the Oregon Growers' Co-operative association against Ernest D. Riddle was dismissed from the circuit court here today and judgment entered against the association for the defendant's costs. This opens the way for an appeal from the court's order and the decision on the defendant's demurrer. The association is suing Mr. Riddle for damages for his failure to deliver his price even as agreed in a contract similar to those signed by growers all over the state. Judge Hamilton, passing upon a demurrer filed by Riddle, held that the contract cannot be enforced as it is not mutual and binds the grower and not the association and is in reality an agent's agreement and cannot be continued over a period of years. The case is one affecting all growers of the state and is being closely watched.
