AT SHERRY'S LAST DAY TODAY

A screen version of Donn Byrne's well-known novel, "The Stranger's Banquet" is the feature at the Sherry Theatre. This is Marshall Neilson's latest photoplay, filmed in association with Goldwyn, and without a doubt his masterpiece, surpassing even such fine pictures as "Dinky" and "Fools First." Neilson had been holding the screen rights of the story for some time, waiting for a chance to give it a properly lavish production. His alliance with Goldwyn put almost limitless resources at his disposal and he began immediately to carry out his plans for filming it.

The result is unusually satisfying. The rest of the cast is uniformly excellent, and includes such well known players as Nigel Barrie, as Derith's weakling brother; Eleanor Boardman as his adventurous wife; Thomas Holding as a labor fanatic; Stuart Holmes, Claude Gillingwater, Dagbar Godowsky, Philo McCullough, Brinsley Shaw, Eugenia Besserer, Lucille Rickson, Edward McWade, Arthur Hoyt and many others in important roles.

THREE DAREDEVILS SEEN IN GREAT OUTDOOR PICTURE

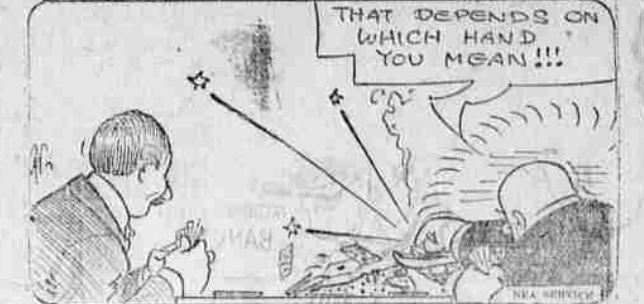
Helen Gibson, Supported By Lea Maloney and Jack Connolly, Seen at the Arcade Theatre.

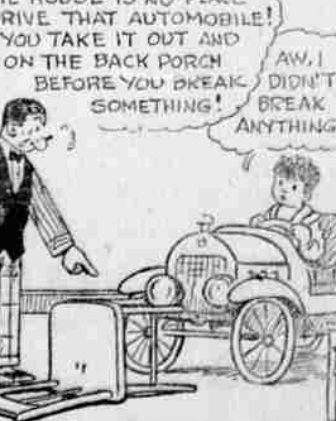
