## Not Flint-like "Carbon"

ALL motor oils deposit some carbonaceous residue, known as "carbon." No oil does otherwise.

But there are two kinds of "carbon." That from some oils attaches to piston heads, spark plugs, and valves. It becomes hard and flint-like. And it stays.

Chisels are required to remove it or acetylene torches to burn it off. It is hard enough to score cylinder walls.

This hard "carbon" acts as an abrasive, wearing cylinder walls, piston rings, bearings, etc.
