Hot Contest Is Expected Here Sunday

Diamond Fans Interested in Contest To Be Played Between Cove, La Grande Fall Teams.

More interest is being shown by local fans in the game of baseball to be played tomorrow at the fairgrounds between the Cove and La Grande league teams at the local fairgrounds than has been exhibited at any time during the past season. And a record-breaking crowd is expected to be present when the umpire announces the batteries and hollers "play ball" at 2:30 o'clock tomorrow afternoon.

White or Martin will start the game on the mound and the remainder of the lineup is undecided. HUTCHISON LEADS GOLF ASPIRANTS

INWOOD, N. Y., July 14.—Jack Hutchinson of Chicago, the genial Scot, and Robert T. Jones of Atlanta, a youth long famous in the golfing world, led a field of 77 aspirants for the national open championship over 36 holes on the Inwood Links Friday. Hutchinson set a new record for the course with his score of 142, a 79 and a 72, and Jones was two strokes away with 144 a card that equaled Joe Kirkwood's low mark in the qualifying rounds.

Firpo Might Fight Wills

NEW YORK, July 14.—Luis Angel Firpo, tireless battler of the Argentine, who added ponderous and aged Jess Willard to his victims Thursday night before a record crowd at Boyl's Thirty Acres, Friday was looking for more pugilistic worlds to conquer.

A series of conferences, however, during the day failed to bring any near prospective match with Jack Dempsey, and indications pointed out to the probability that Firpo, admittedly still lacking in the finer points of ring science, would have one or two testing matches before he gets a shot at the title.

As a matter of fact, Firpo, in course of a long talk with Tex Rickard Friday, at Madison Square Garden, expressed a desire to fight Harry Wills, New Orleans negro, who has stood as a title challenger for more than a year, before meeting Dempsey. The sombre South American, bearing no outward marks of the conflict, in which he crushed the comeback hopes of the former pioniar, Thursday night, laconically added that he was ready to "fight anybody, any time any place."

Rickard also conferred at some length with Jack Kearns, Dempsey's manager, but said that he had no definite match in sight, although he hopes to put on another heavyweight show, either as a further elimination or for the title, around Labor day at Boyl's Thirty Acres.

Memoirs of Pioneer of Union County

J. L. Caviness.

J. L. Caviness was born in Morgan Co., Indiana, December 7th, 1789, crossed the plains to Oregon in 1832, engaged in mining and stock raising. He had much experience in frontier life, coming west as he did. He was denied the privilege of schools, and is a self-made man. At the age of sixteen he engaged one year as herder to drive stock to Calif. In 1834 he took part in the Rogue River Indian trouble as messenger and scout. Many long and perilous trips he took through all kinds of weather, day or night.

Later he went to The Dalles to help the soldiers in forcing out the savages, after which he went to Washington and joined forces under the famous Step-toe and for one and one-half years he followed this daring life.

For the next few years he followed freighting and until 1861 when he came to Grande Ronde Valley he bought 220 acres of land where Island City now stands, built a flouring mill and laid out a town site.

He still owns much valuable property in the county, having been identified with the development of the county in the same earnest way he pursued other courses of business and

adventure.

His name will go down in history as one of the substantial citizens of Oregon.

In 1863, Mr. Caviness married Miss Cassie Scott, daughter of John and Sarah (Kennedy) Scotts. To this union were born five children: Nellie J., married to J. A. Braunsen, living at Joseph-Wallowa County; William H., deceased; Laura, married to C. H. Conkey in La Grande, Laurence, married to Annie Mitchell also living in Wallowa county, Gracie, married to Dr. N. Muller now living in California.

Ten Racing Cars Entered in Boise Auto Classic

BOISE, July 14.—Ten autos, the flower of racing cars in southeastern Idaho and eastern Oregon, will line up at 2 o'clock this afternoon to await the starter's gun for the Idaho Auto Racing association competition on the half-mile dirt track at the state fairgrounds.

The first event, according to the program, will be one mile against time for all cars entered, for which a cash purse has been hung up for the fastest mile. Then will follow four races of 10 miles, 15 miles, 5 miles and 25 miles. The 5-mile race will be open to all cars.
